

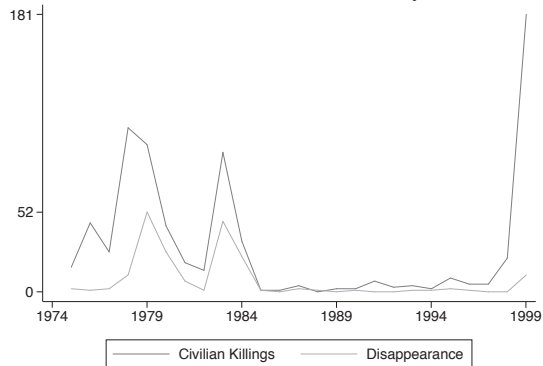

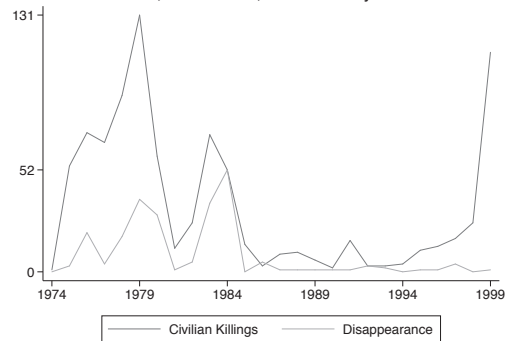
Fatal Violations over time, 1974–1999, committed by Territorial Units

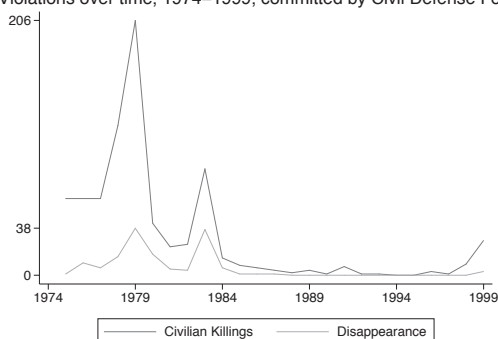
Fatal Violations over time, 1974–1999, committed by Non-Territorial Units

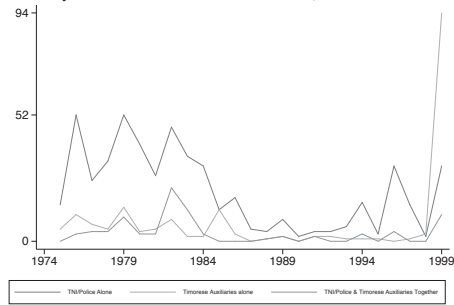

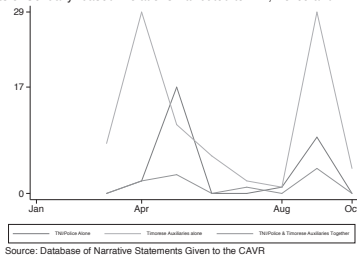
Attributed Acts of Sexually-based violations Attributed to TNI, Police and Timorese Auxiliaries, 1974-1999

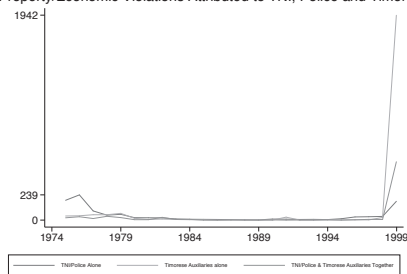
Attributed Acts of Sexually-based Violations Attributed to TNI, Police and Timorese Auxiliaries, 1999

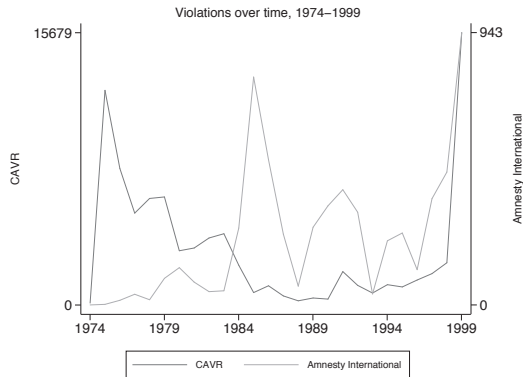

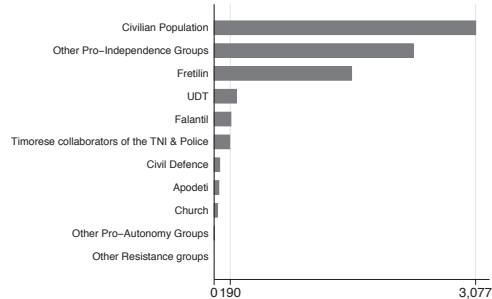

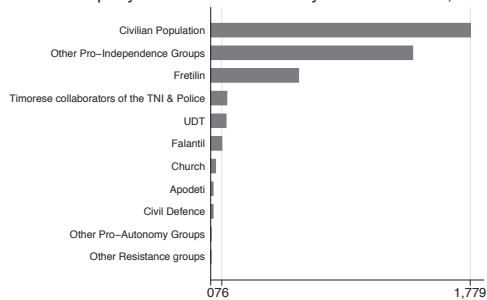
Reported Acts of Ill-Treatment by Victim Affiliation, 1974–1999

Reported Acts of Property/Economic Violations by Victim Affiliation, 1974–1999

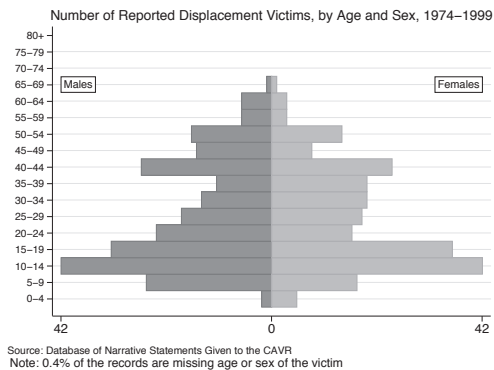

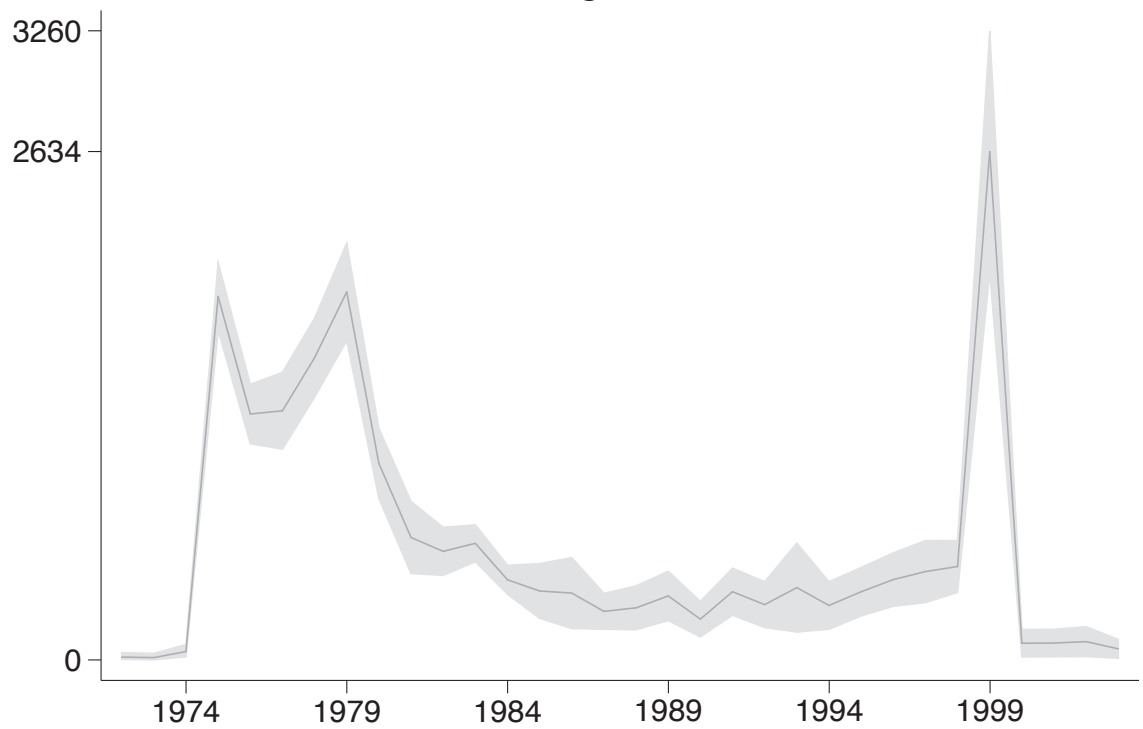
### Estimated total killings in Timor-Leste



Total estimated deaths by deprivation: 16090 (+/- 4426)

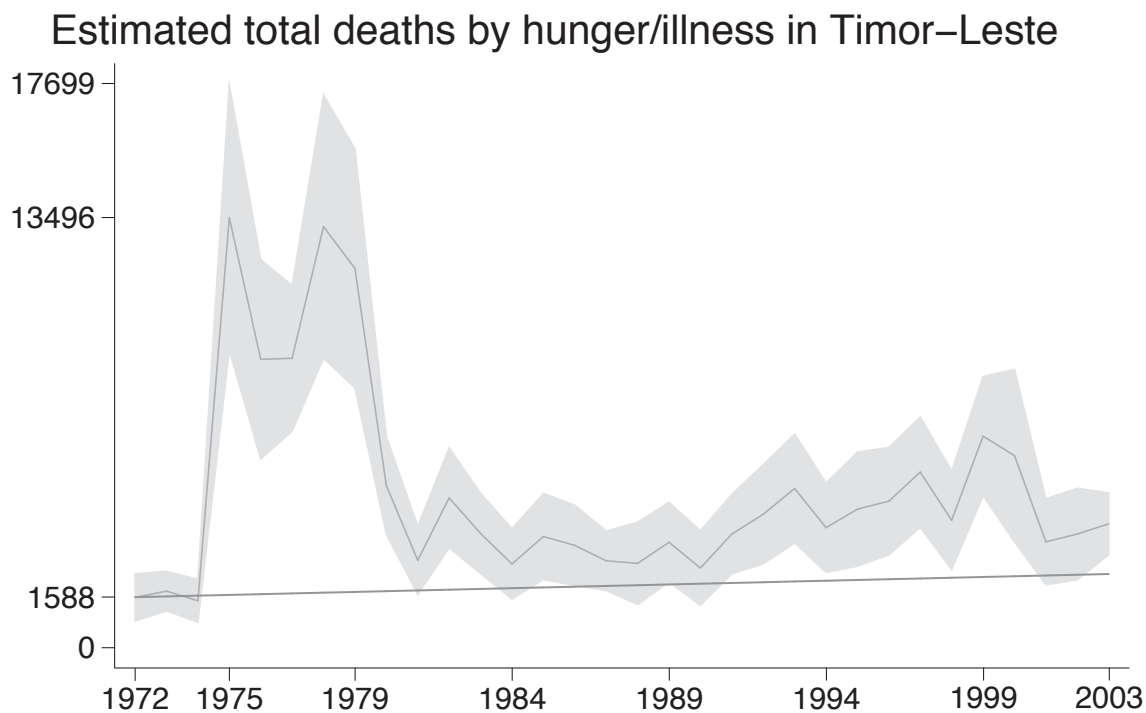

Estimated total killings in Timor-Leste

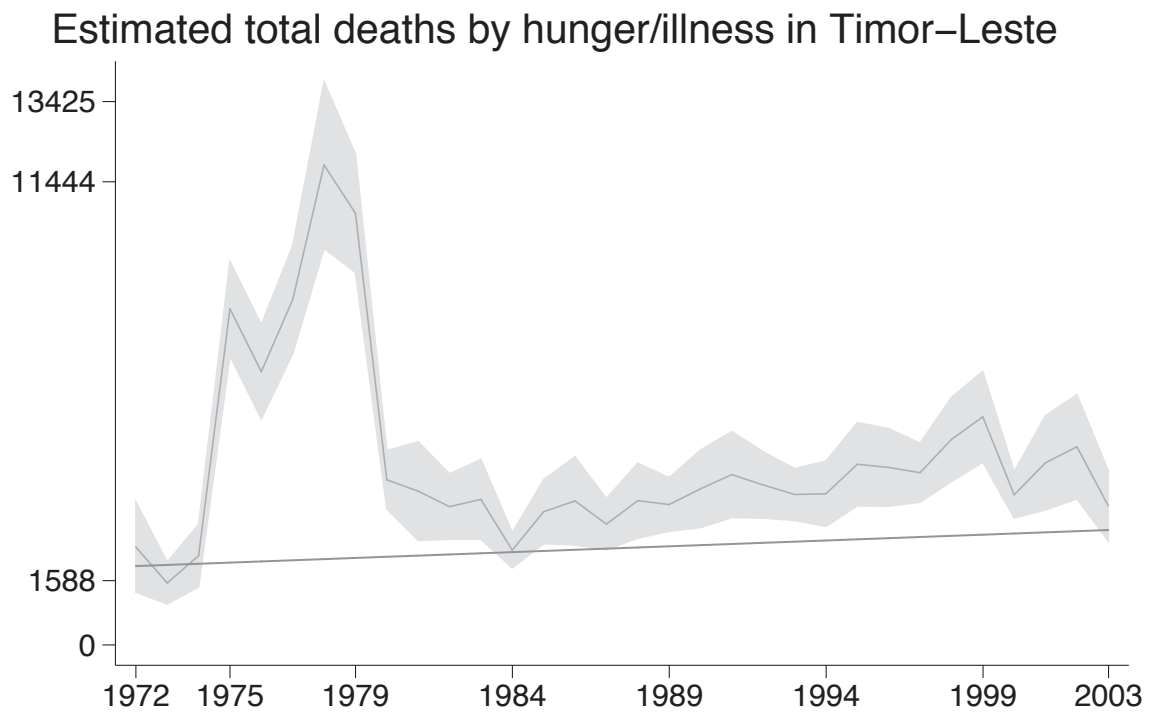


Estimated total killings, 1975–1999: 18571 (+/- 982)

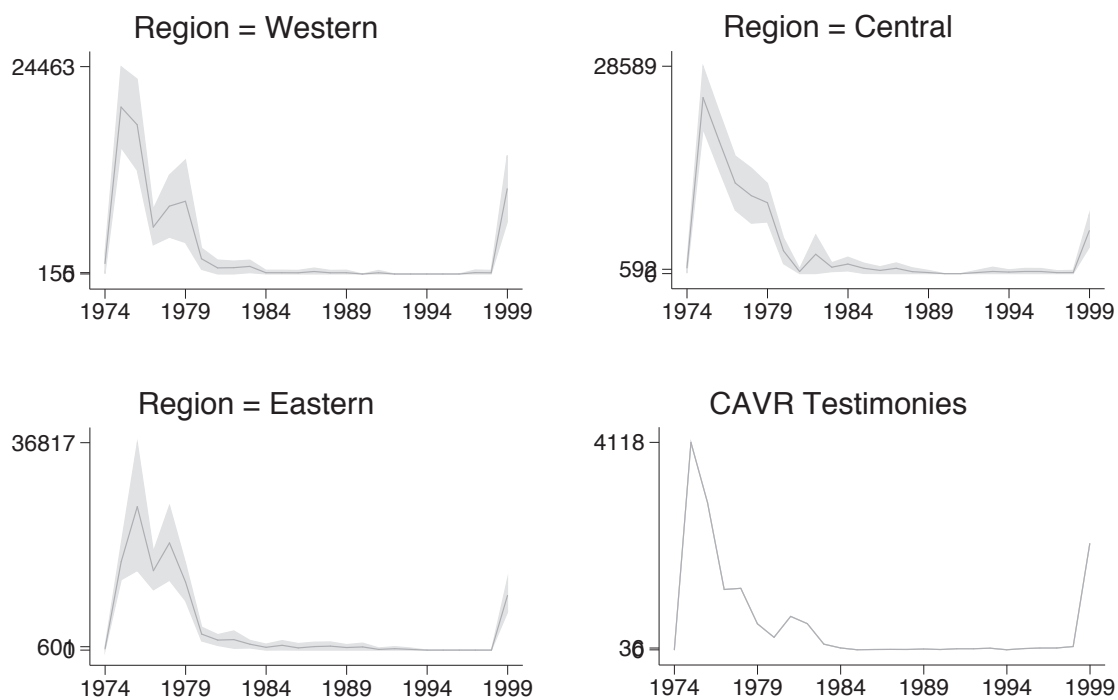


Total estimated deaths by hunger/illness, 1972–2003: 161098 (+/- 10962)

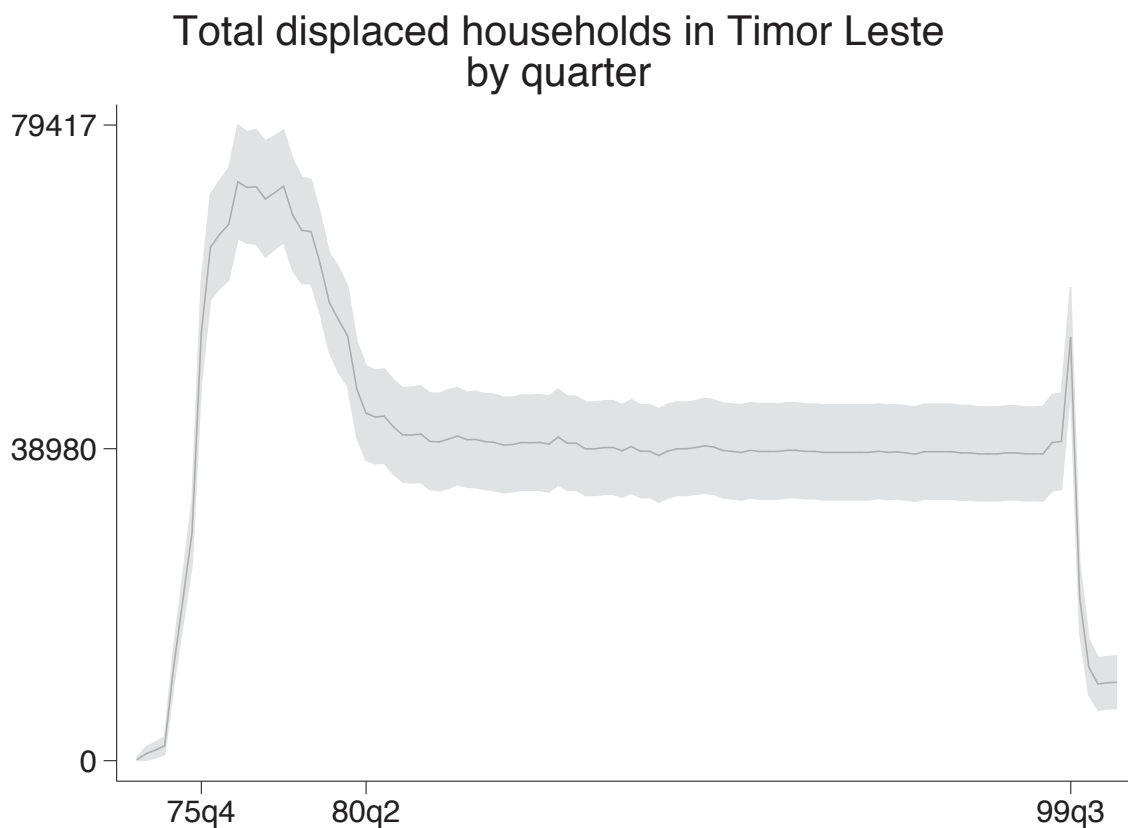

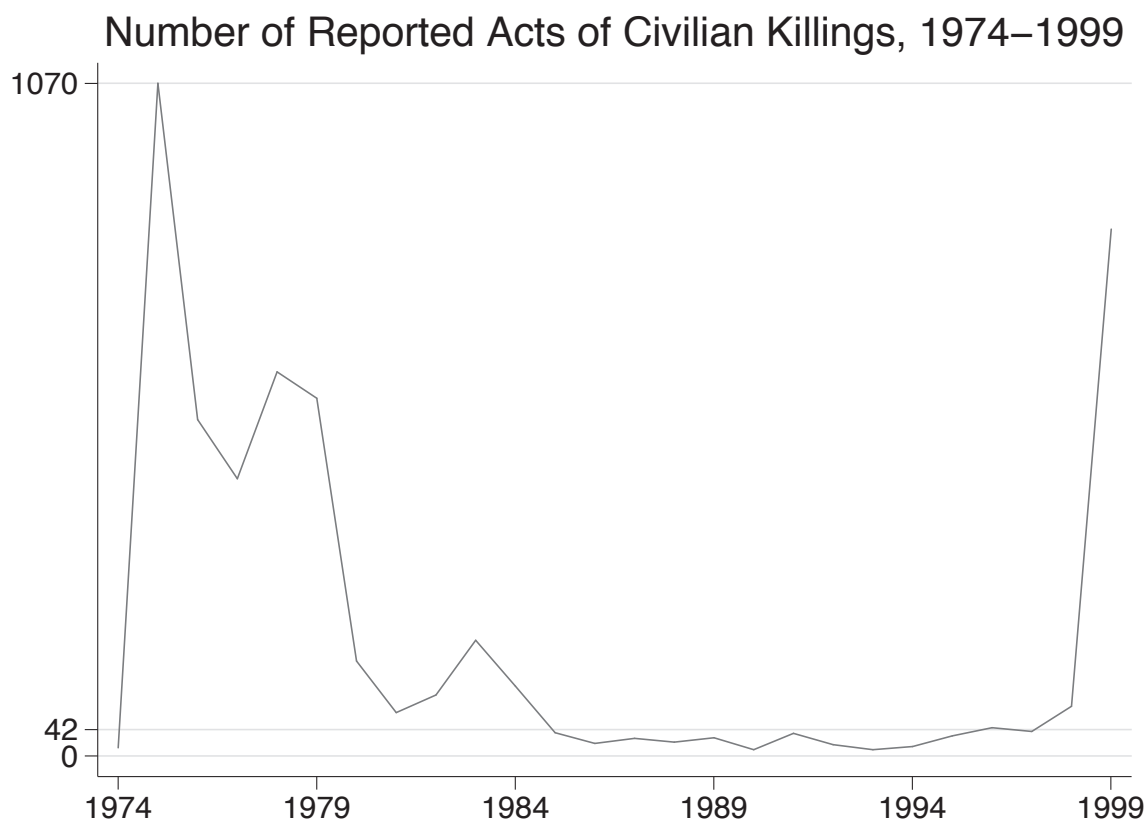
### Estimated displacement events in Timor Leste (with error bands)



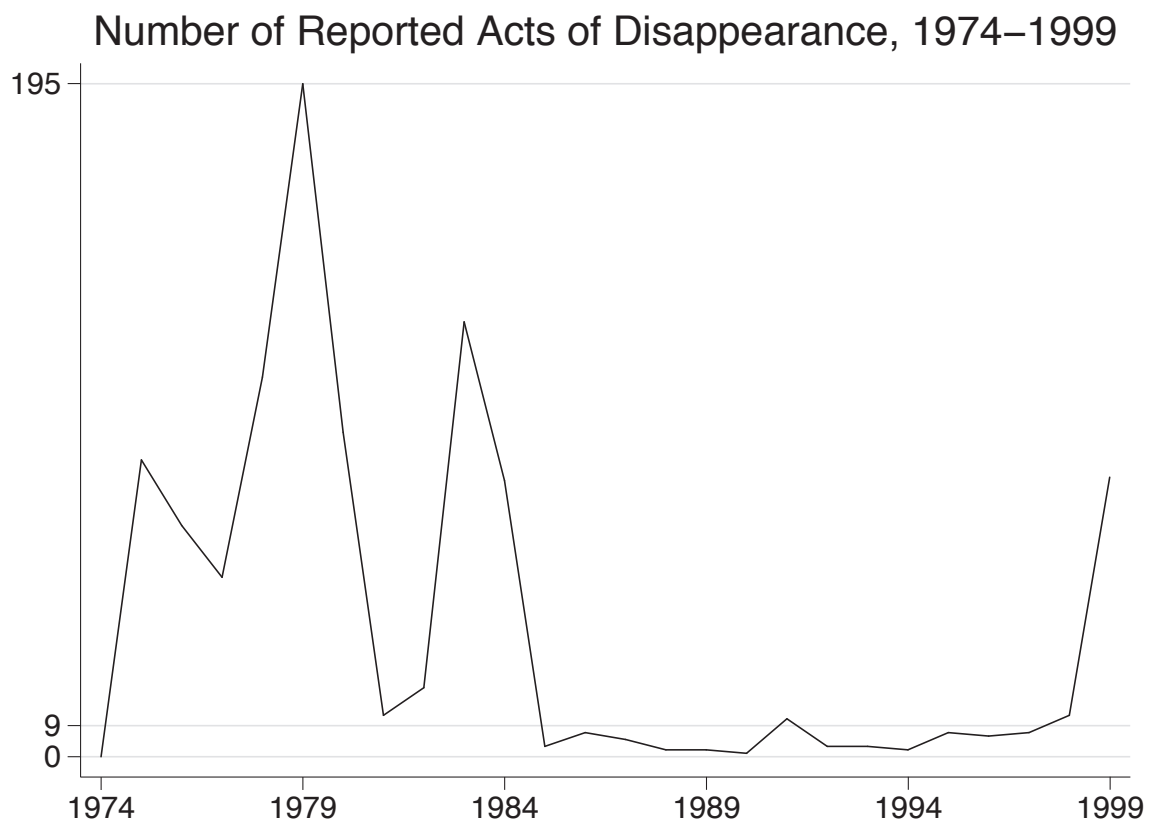

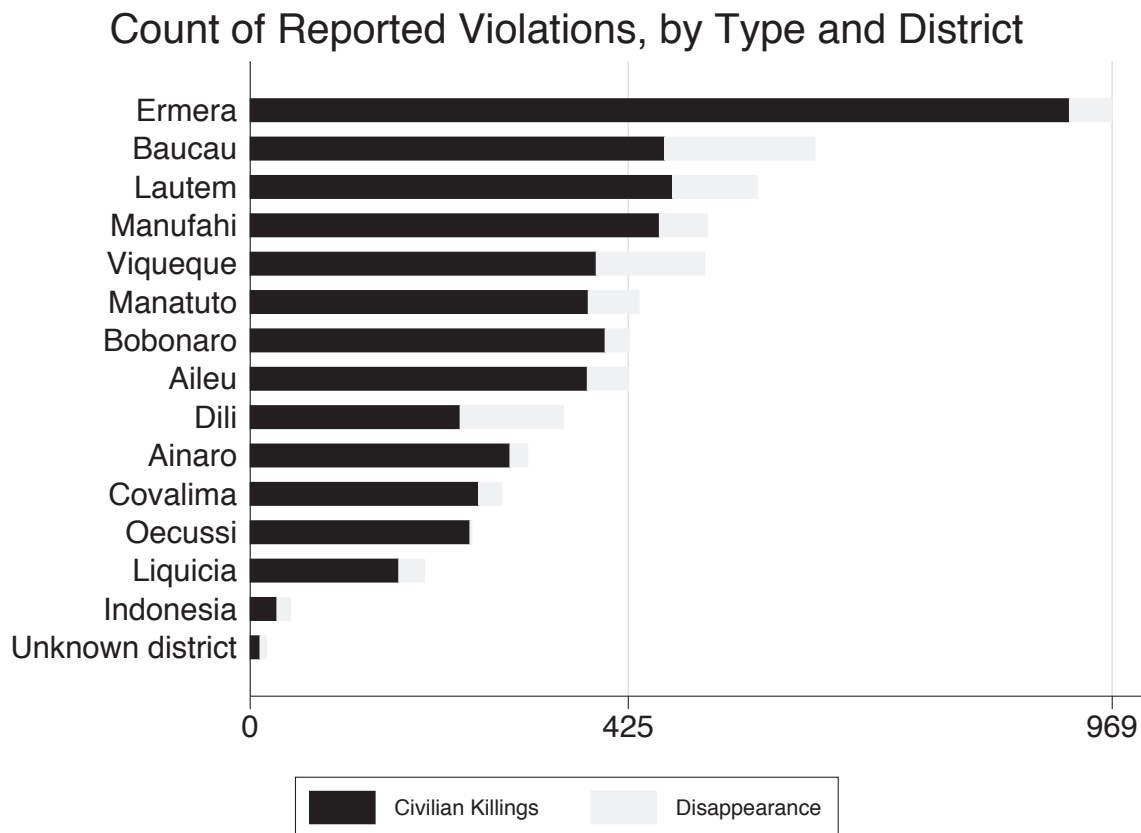

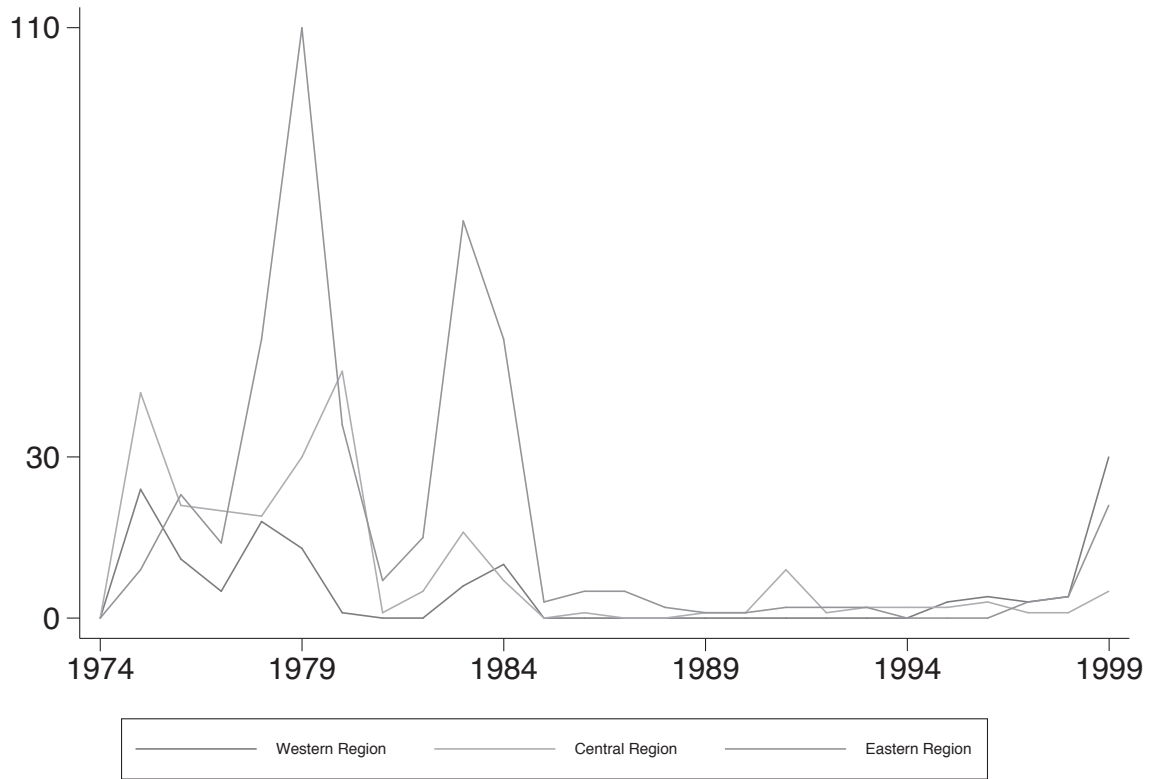

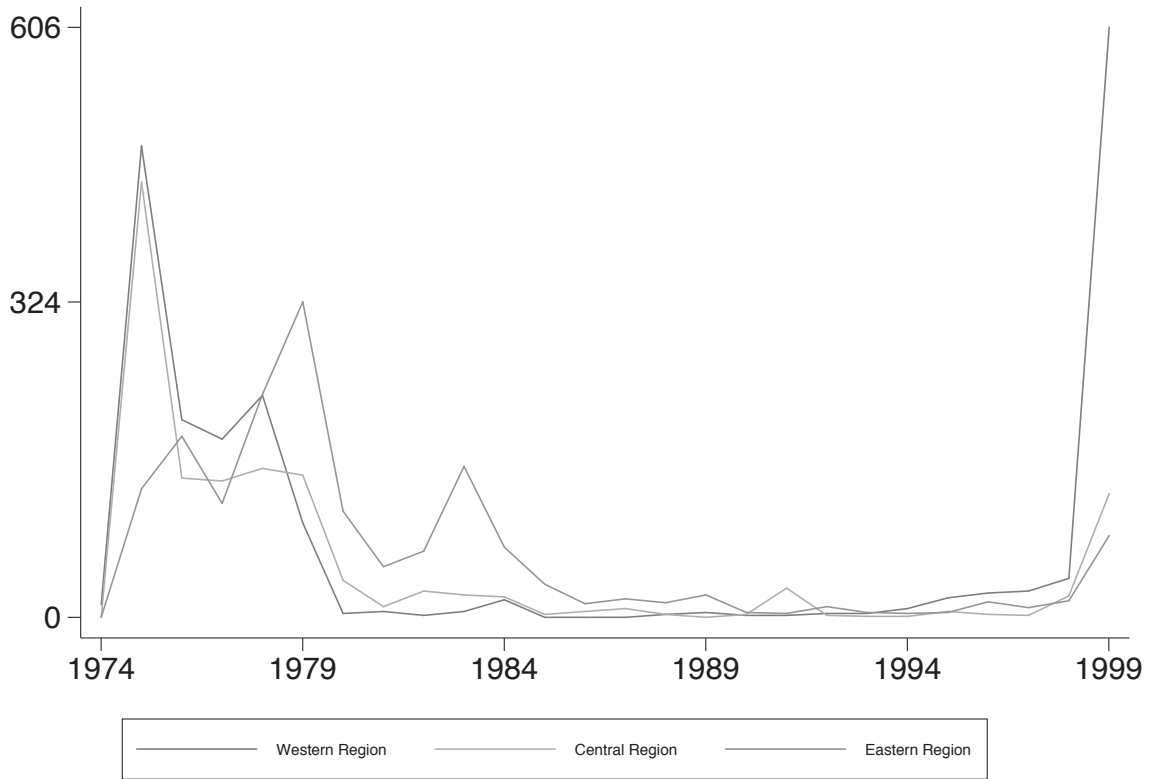


Count of Disappearance by Region Over Time, 1974–1999

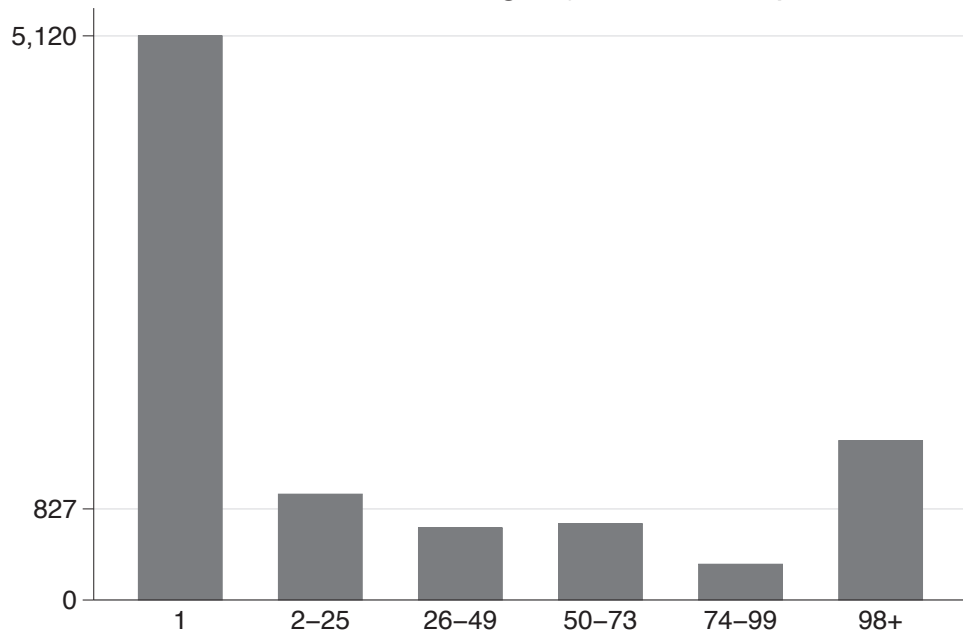

Count of Victims of Acts of Civilian Killings by Victim Group Size, 1974–1999



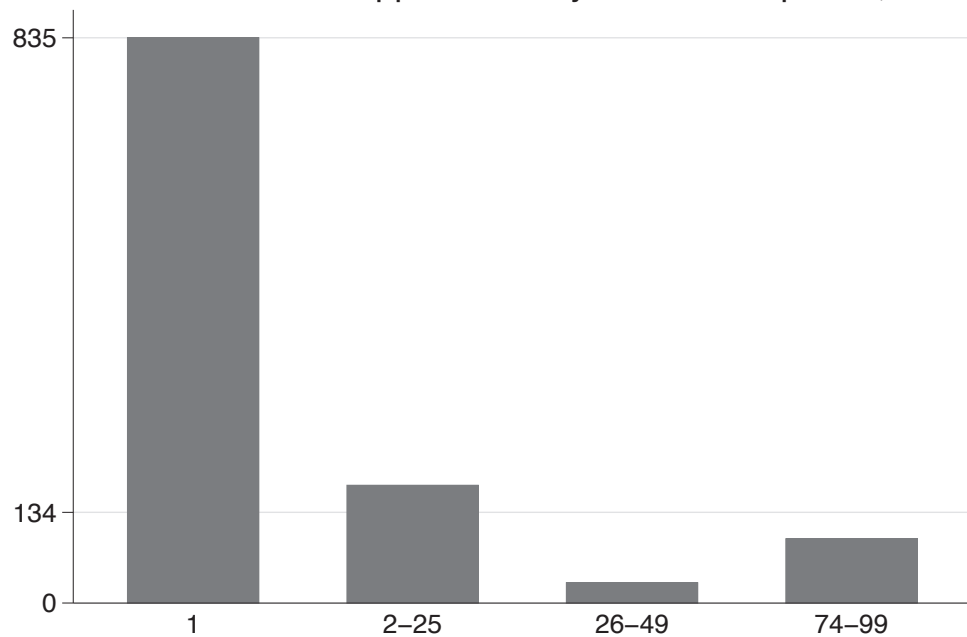

Count of Victims of Acts of Disappearance by Victim Group Size, 1974–1999

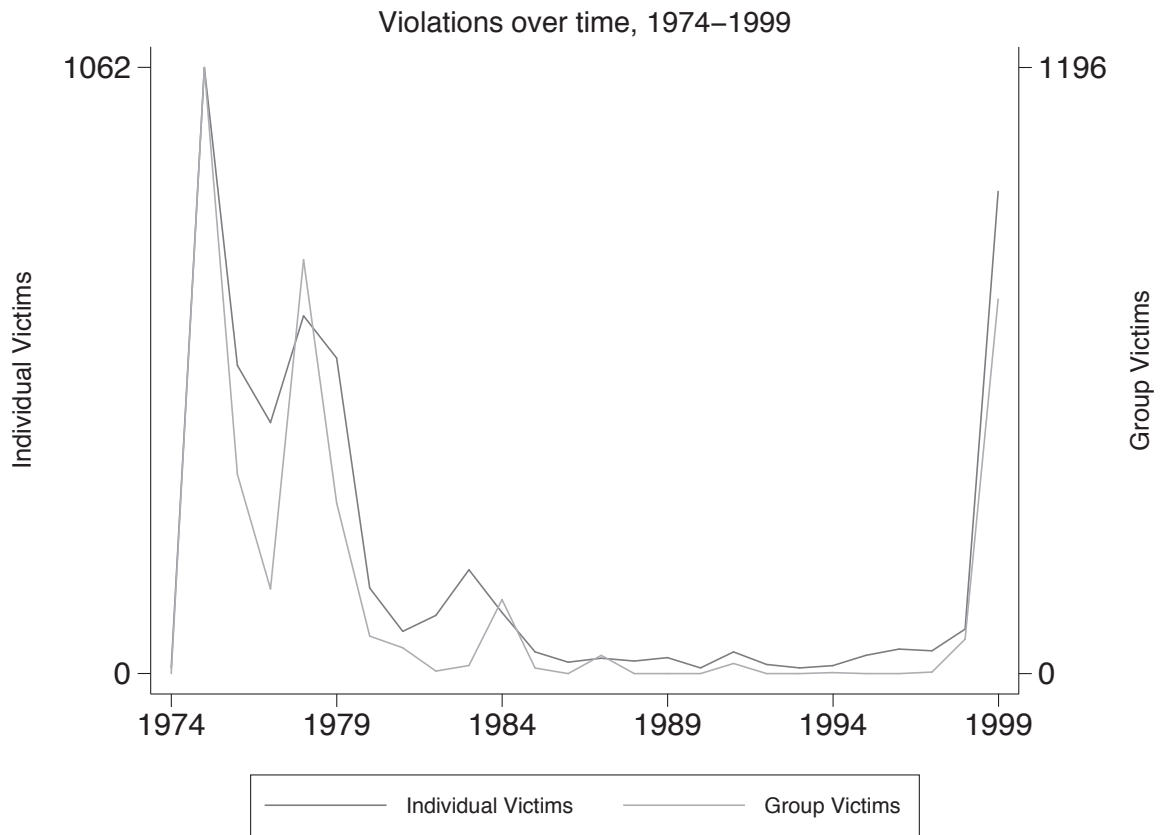

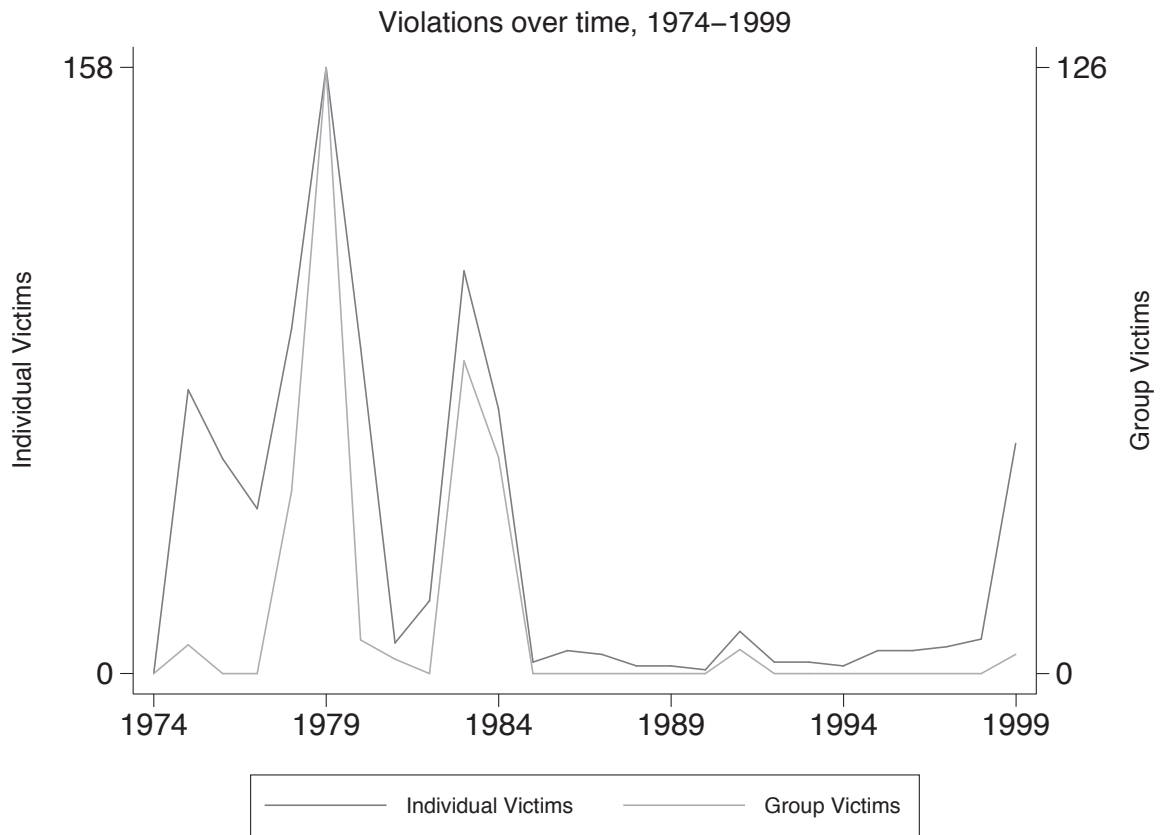

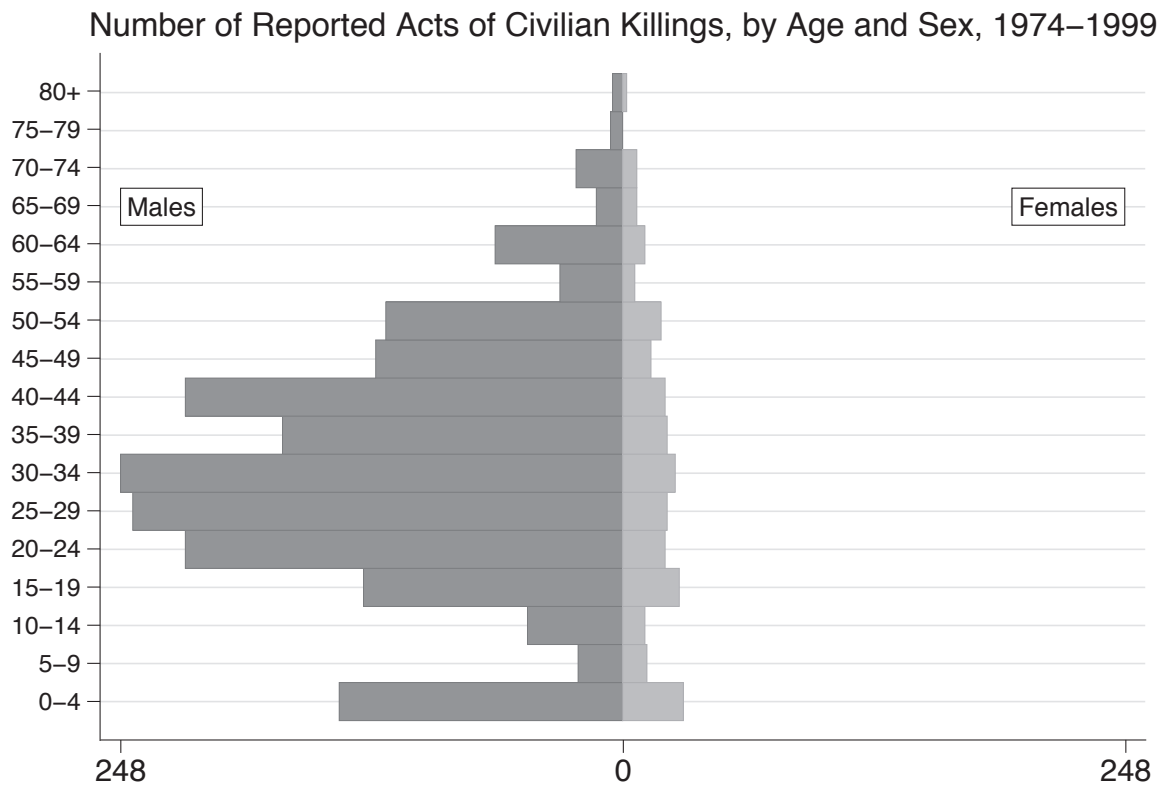

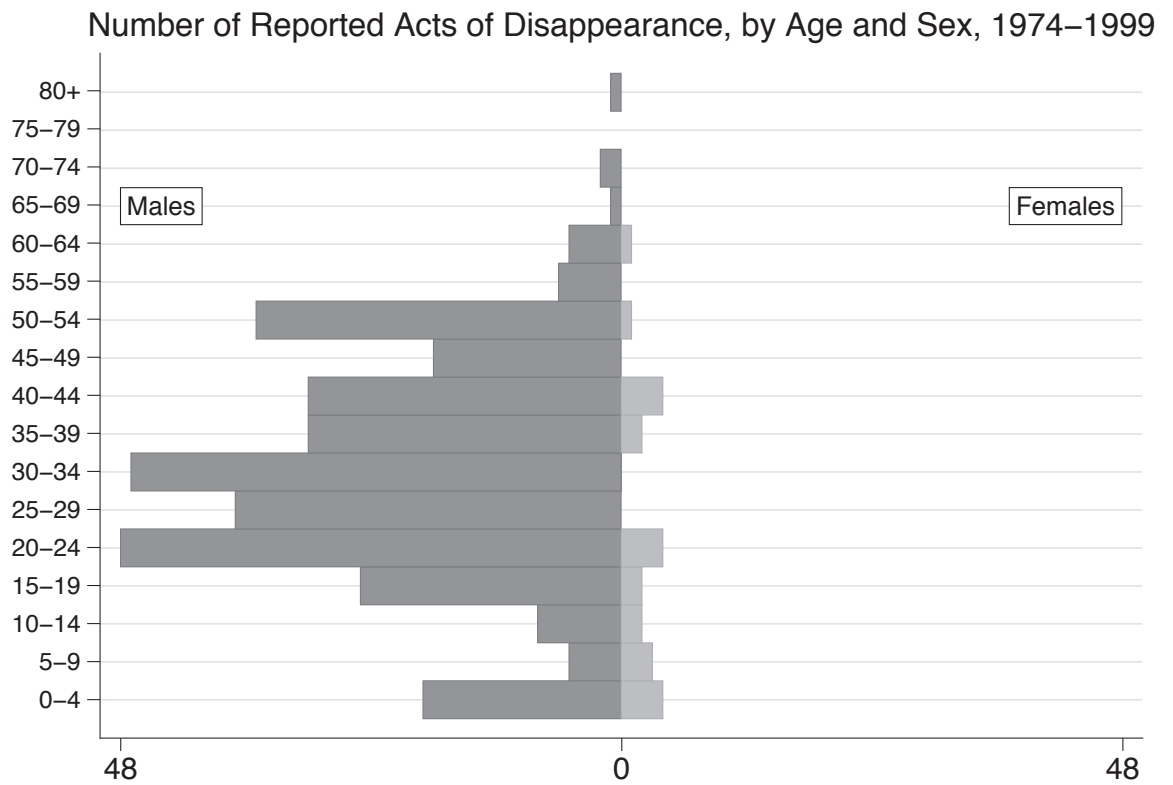

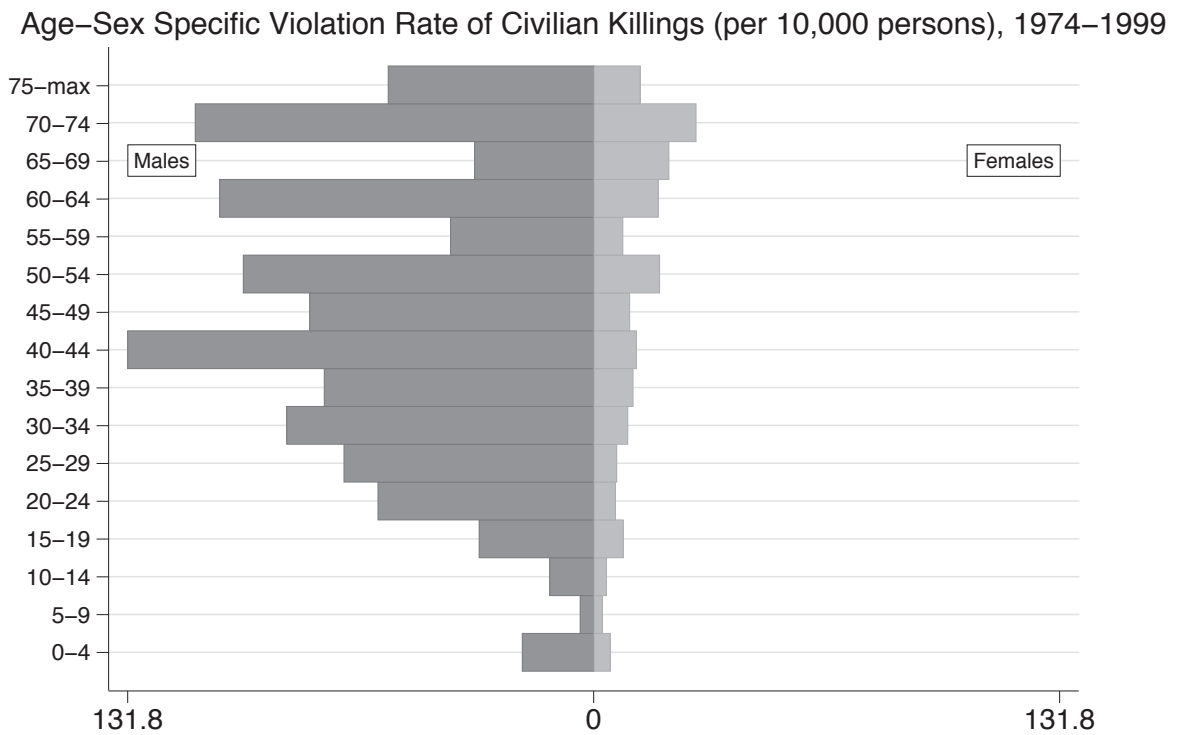

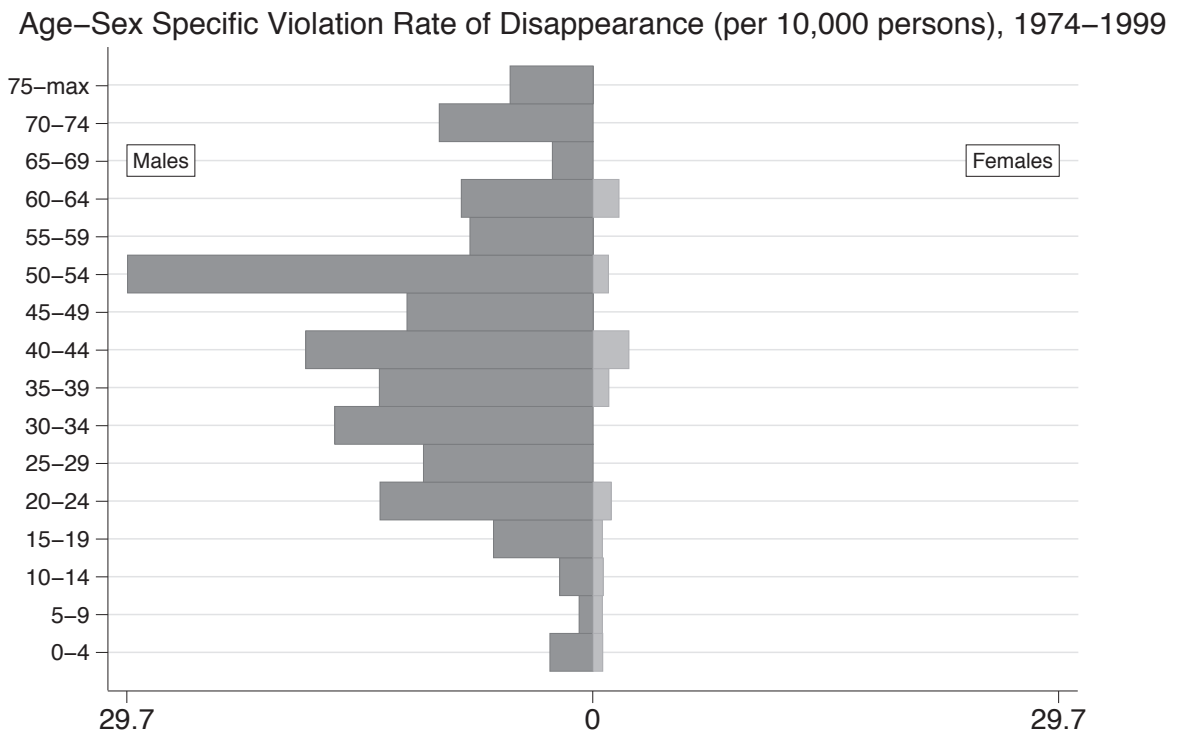

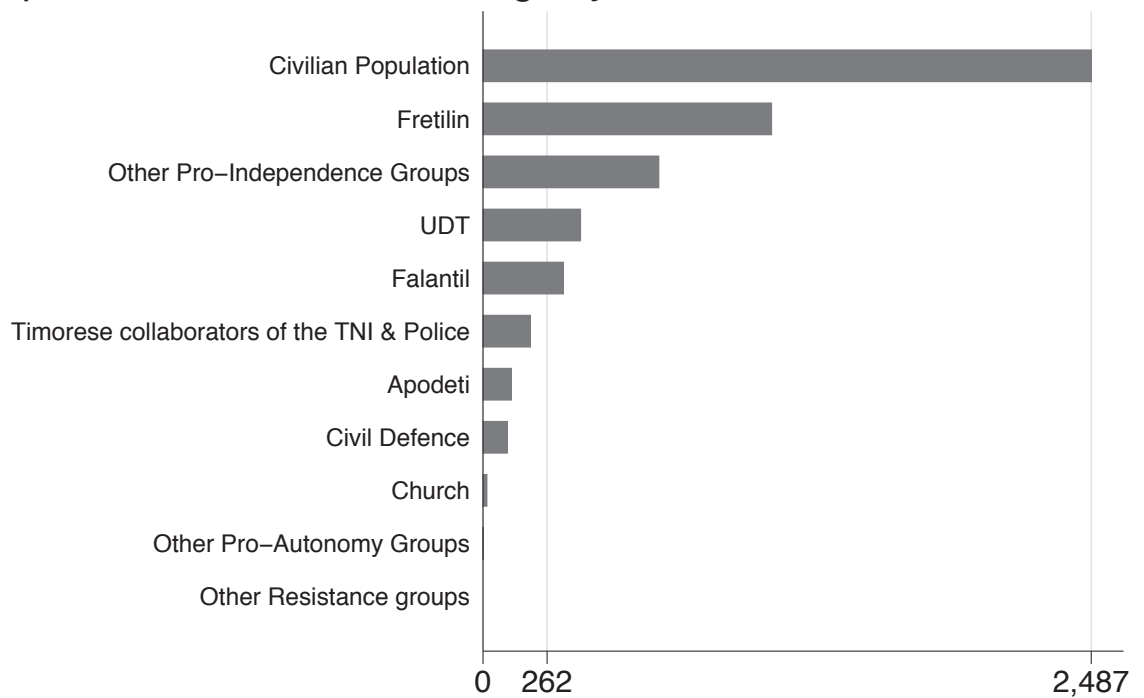

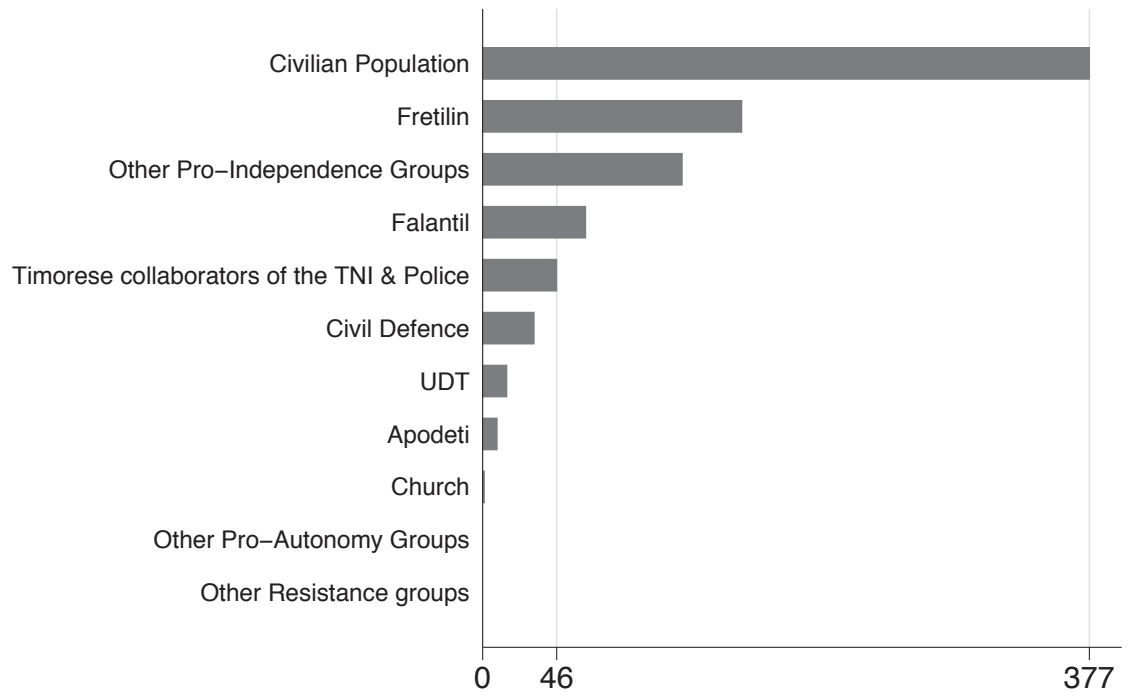

### Reported Acts of Civilian Killings by Victim Affiliation, 1974–1999

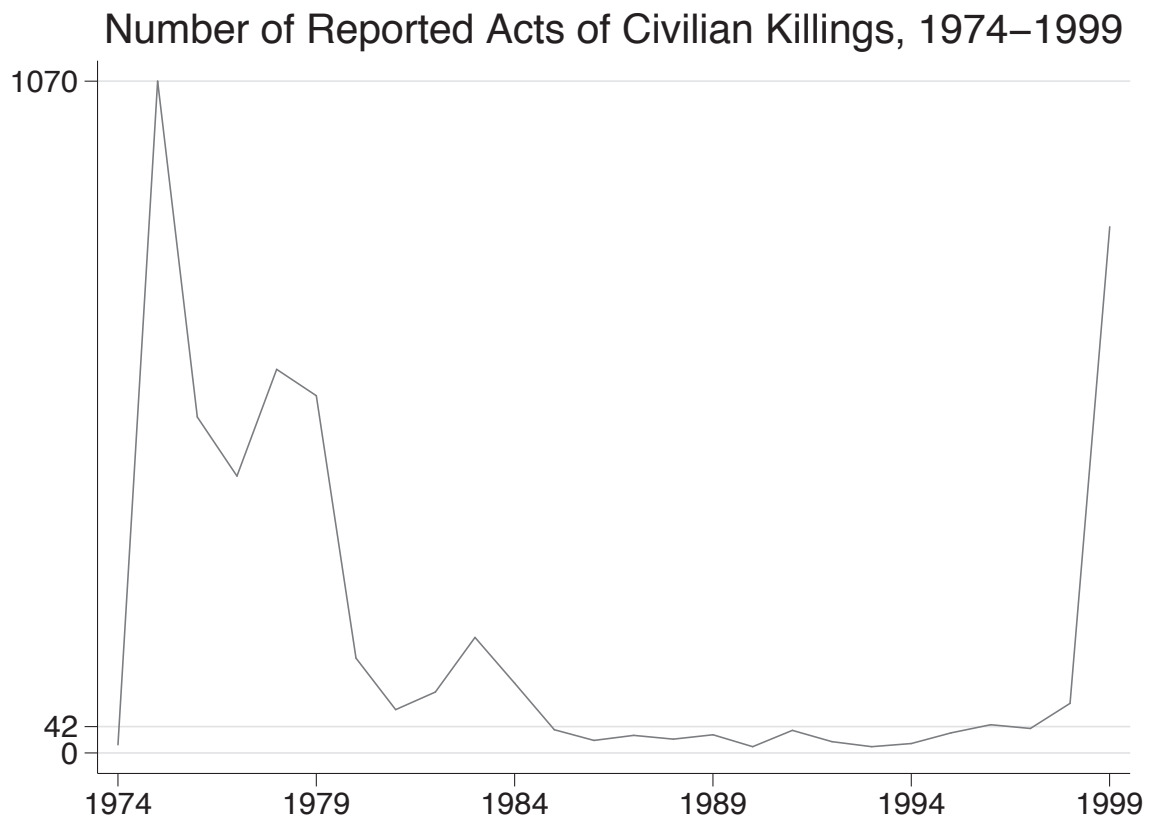

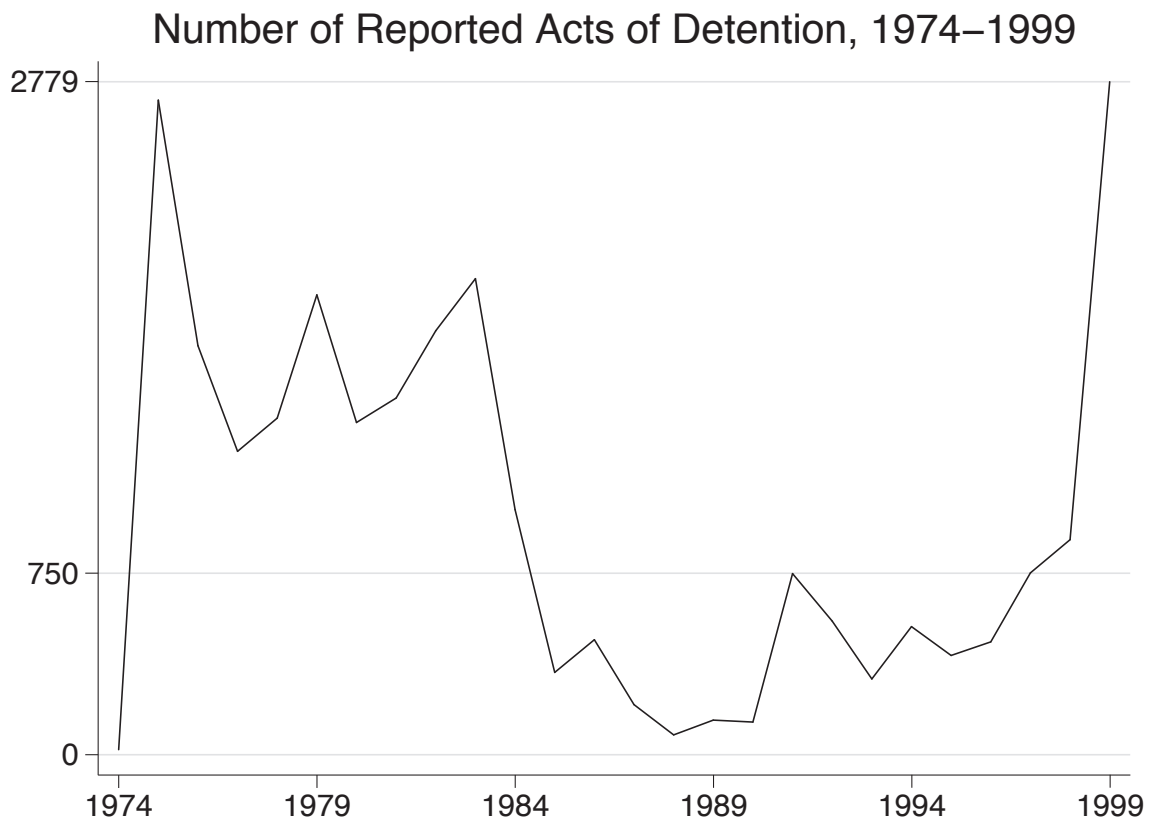
### Reported Acts of Disappearance by Victim Affiliation, 1974–1999

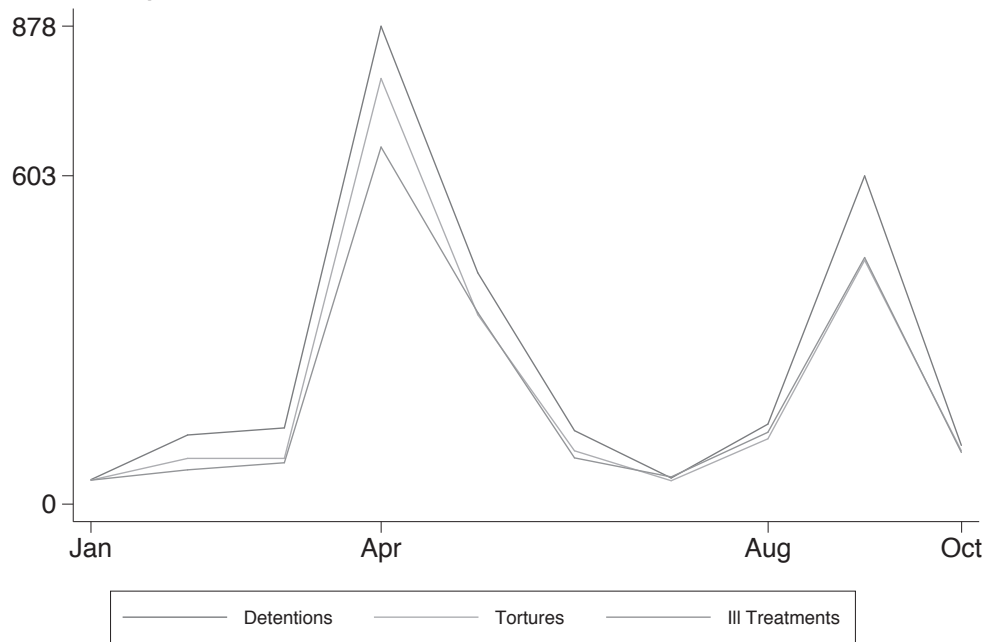

Count of Reported Acts of Detention, Torture & Ill-Treatment, 1999

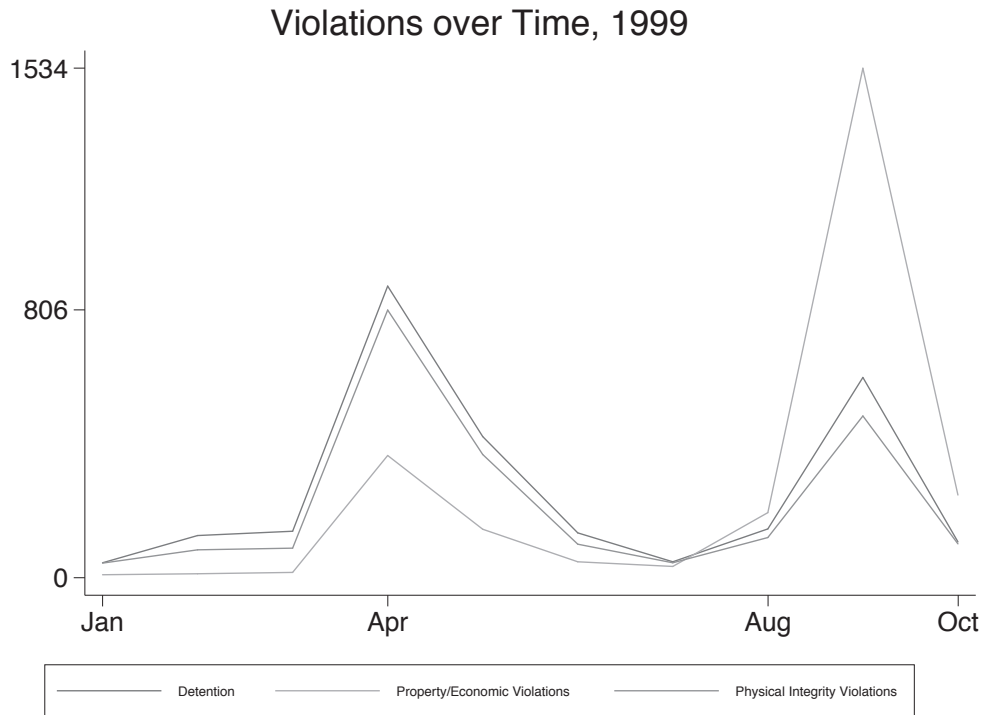

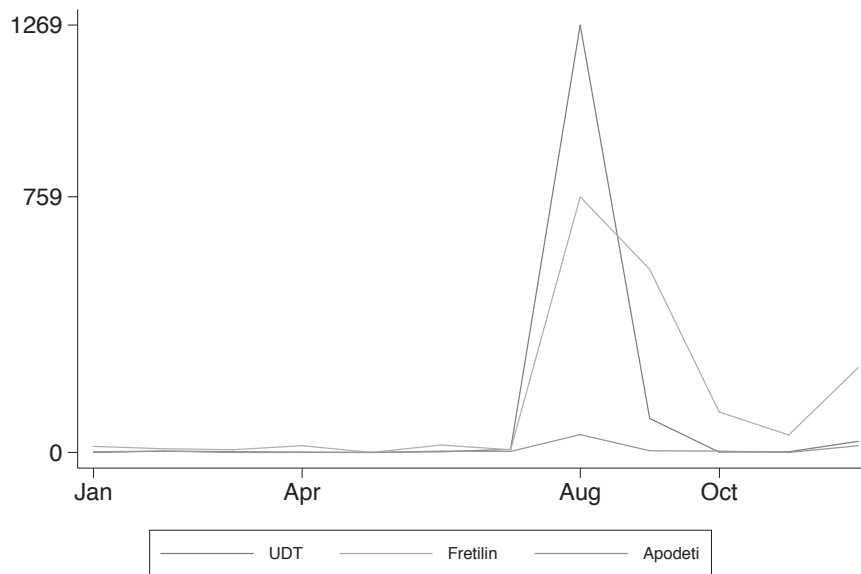

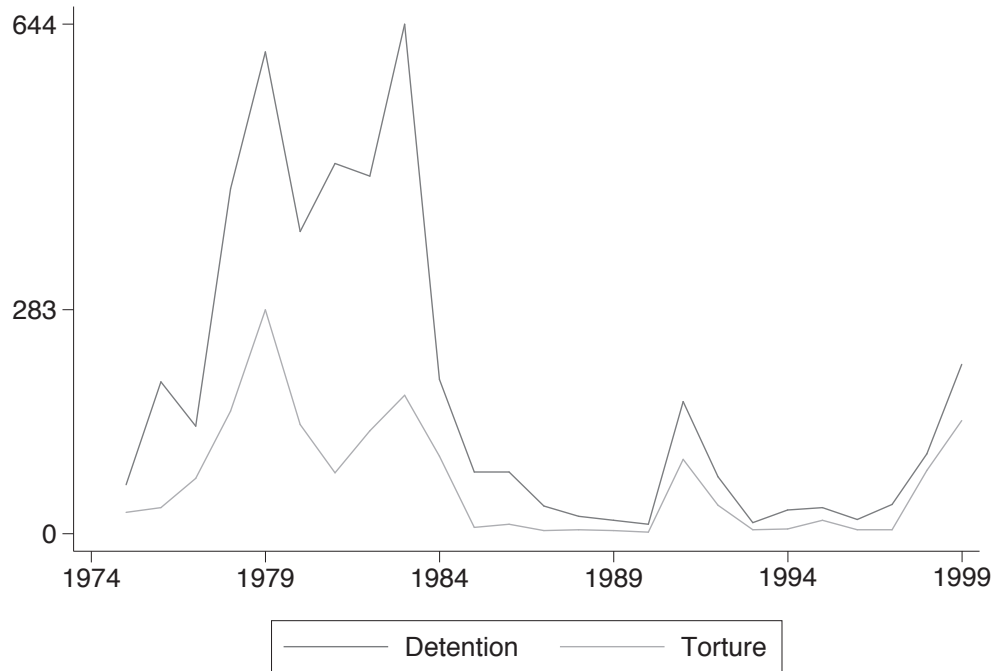

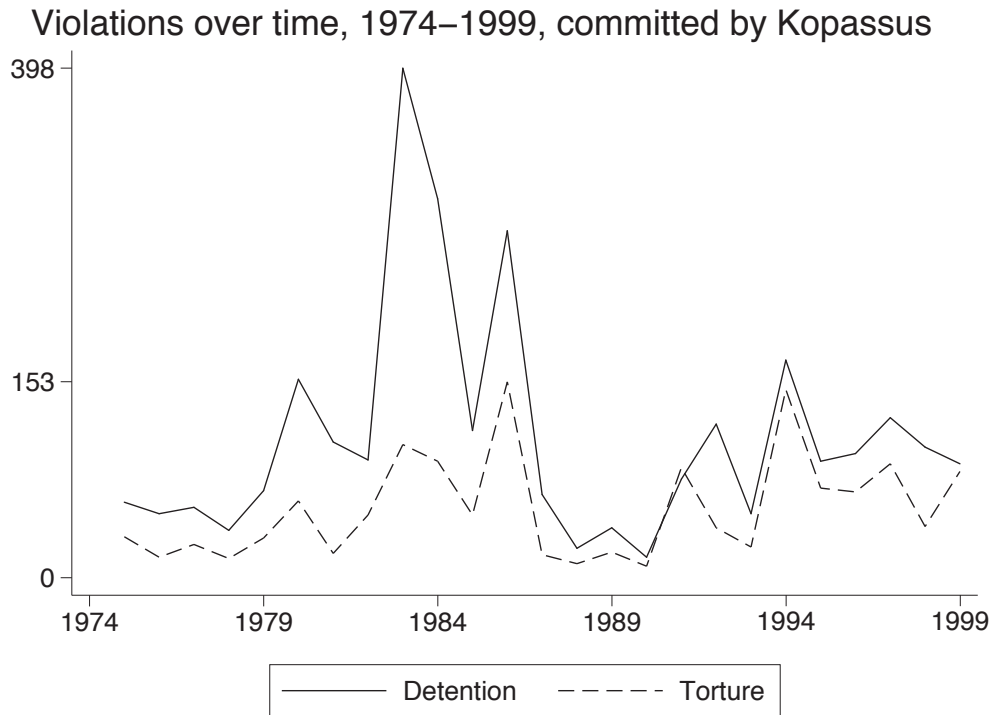
Non Fatal Violations over time, 1974–1999, committed by Civil Defense Forces:

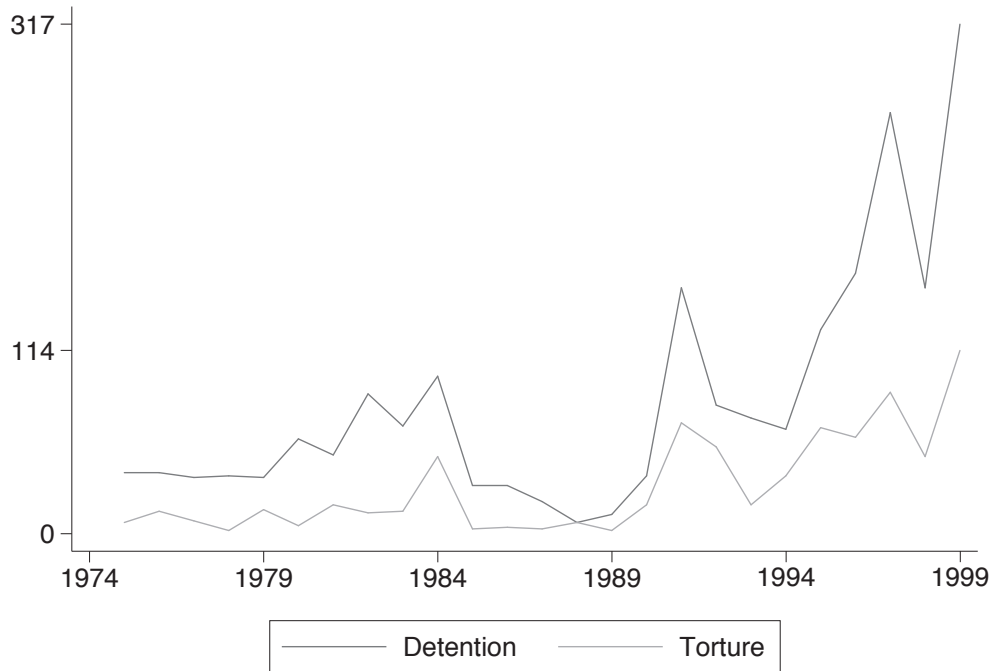

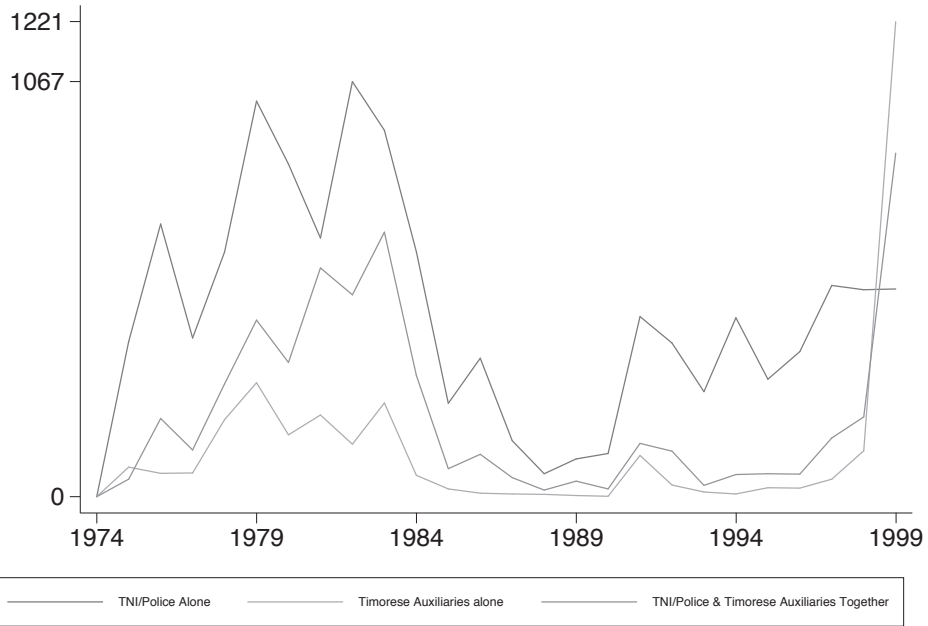

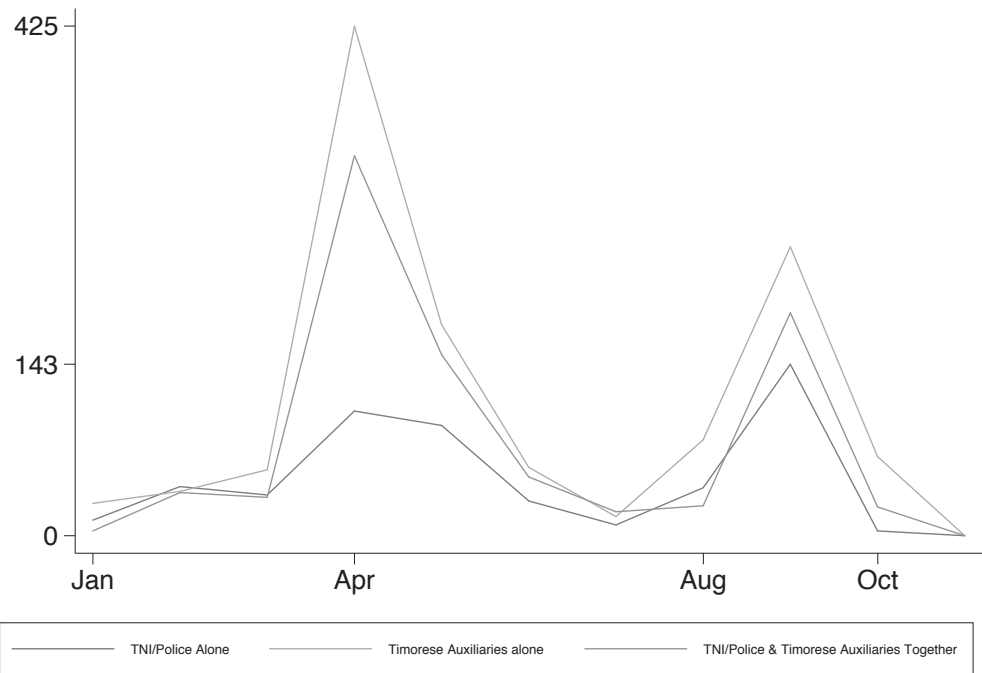
Reported Acts of Detention Attributed to TNI, Police and Timorese Auxiliaries, 1974–1999

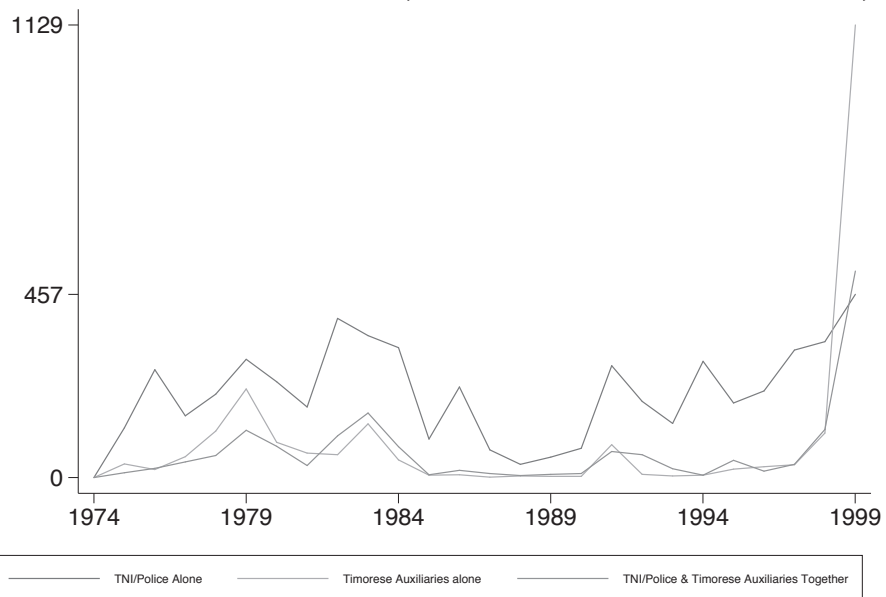

Reported Acts of Torture Attributed to TNI, Police and Timorese Auxiliaries, 1974–1999



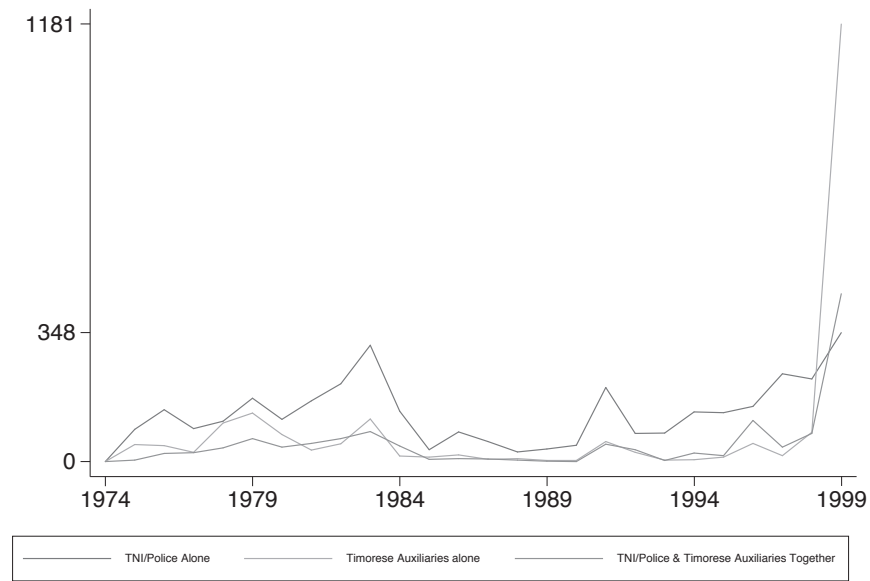

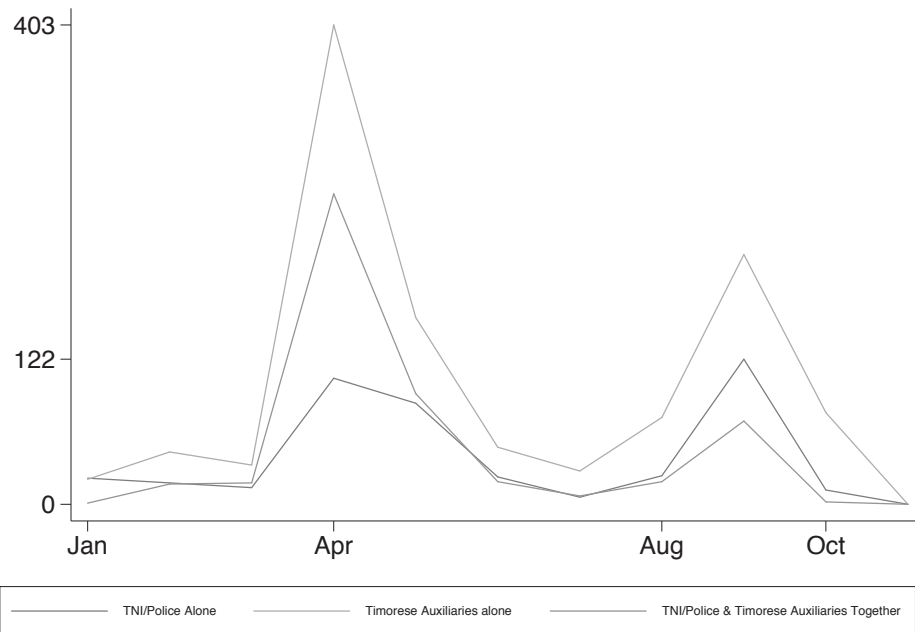

Reported Acts of Torture Attributed to TNI, Police and Timorese Auxiliaries, 1999

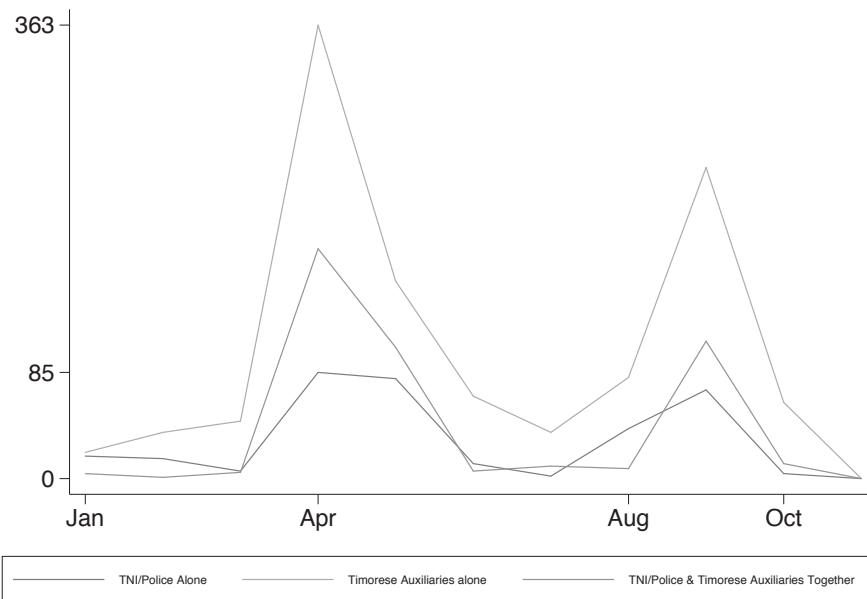

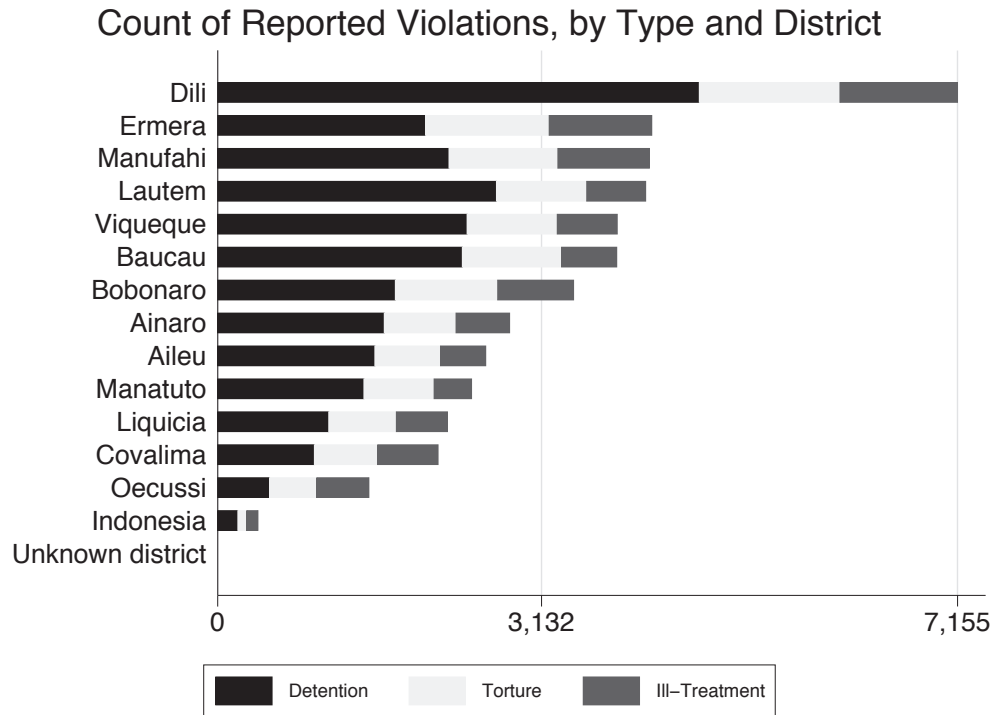

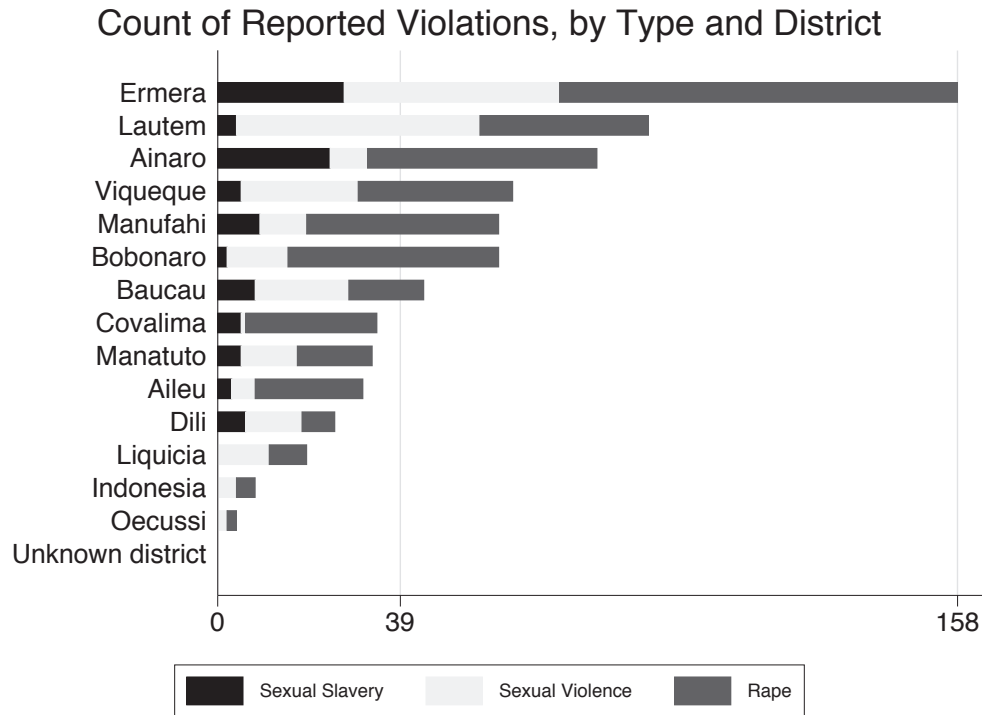

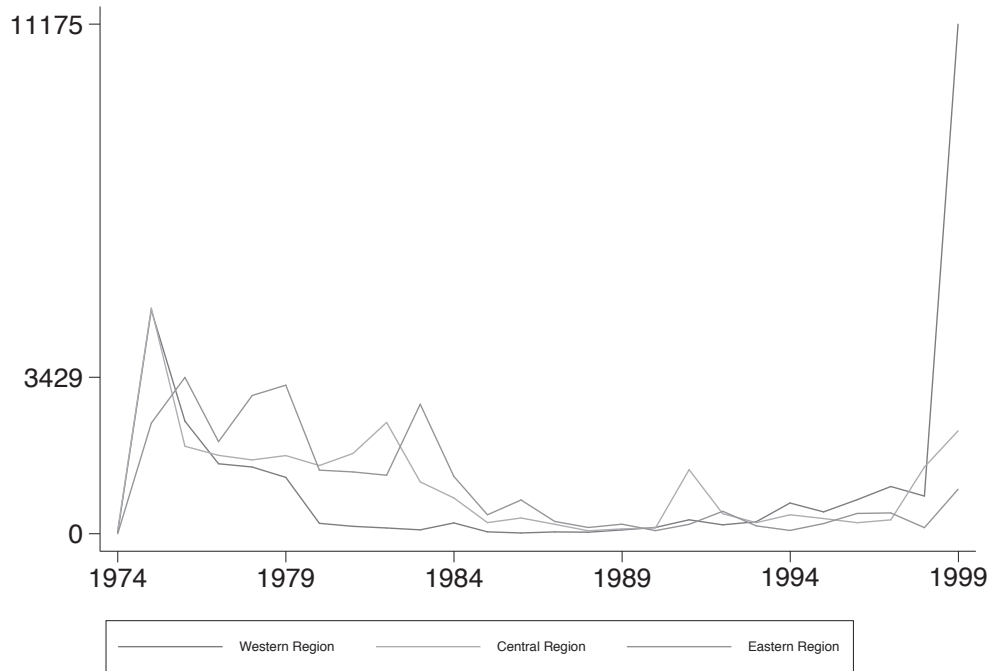

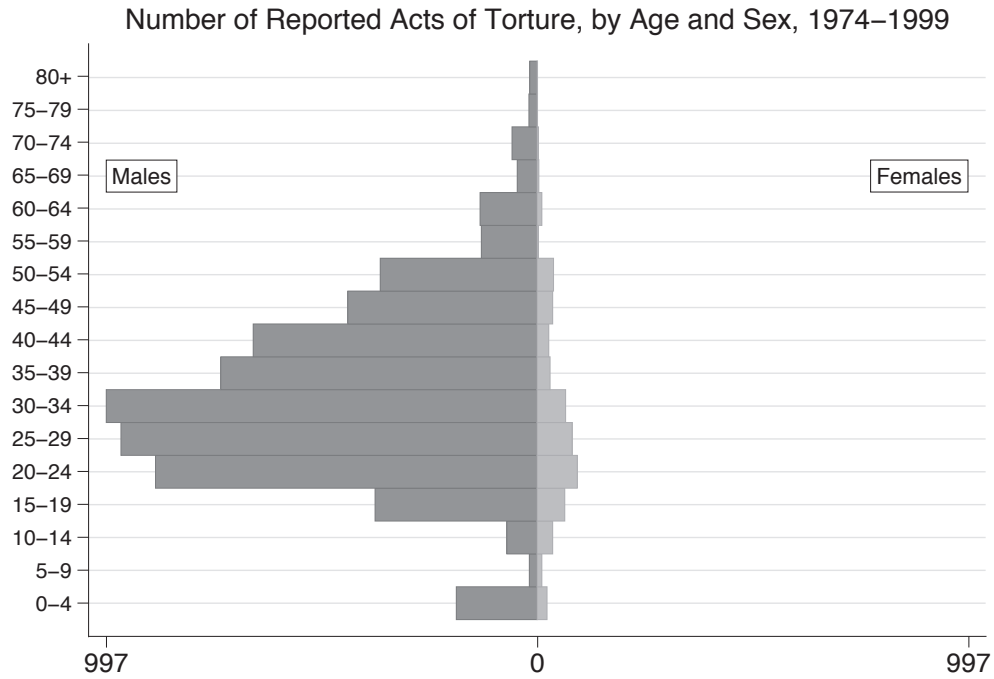

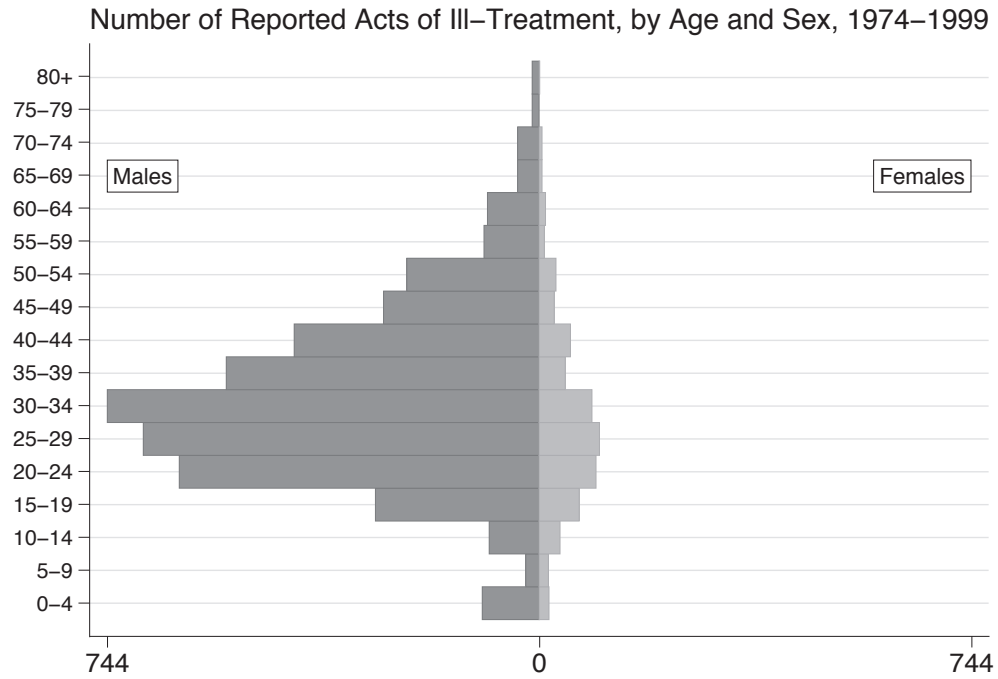

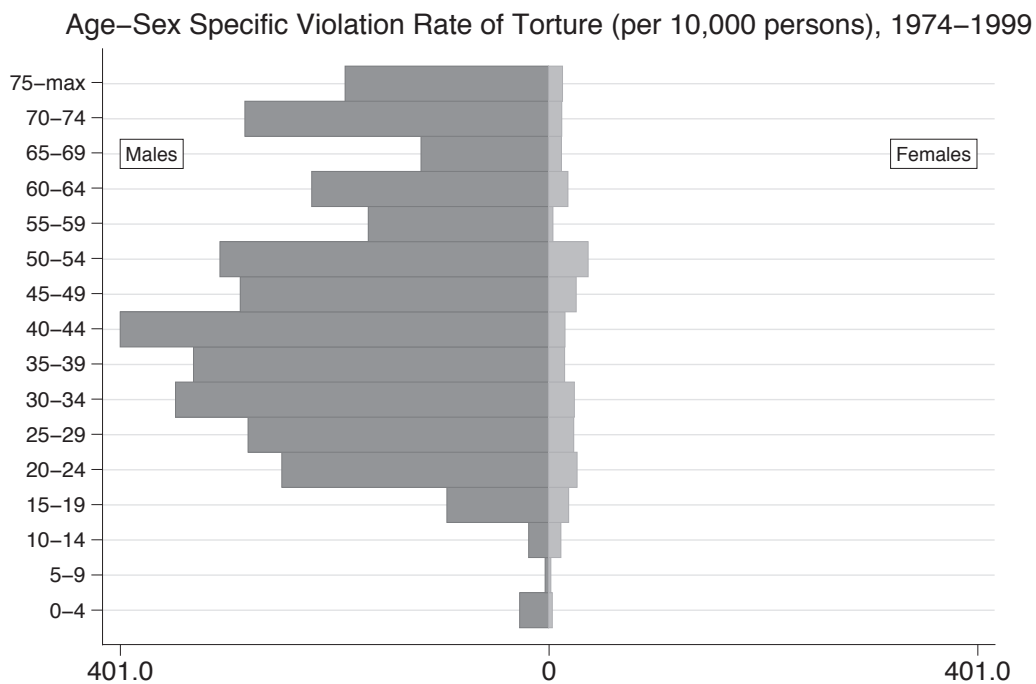

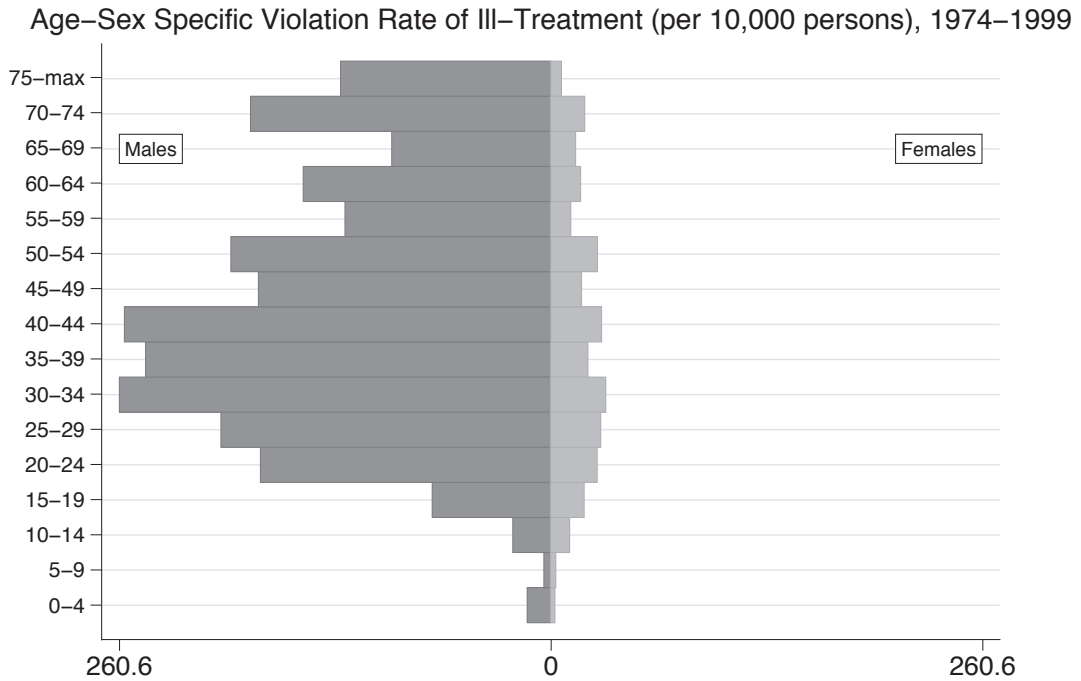

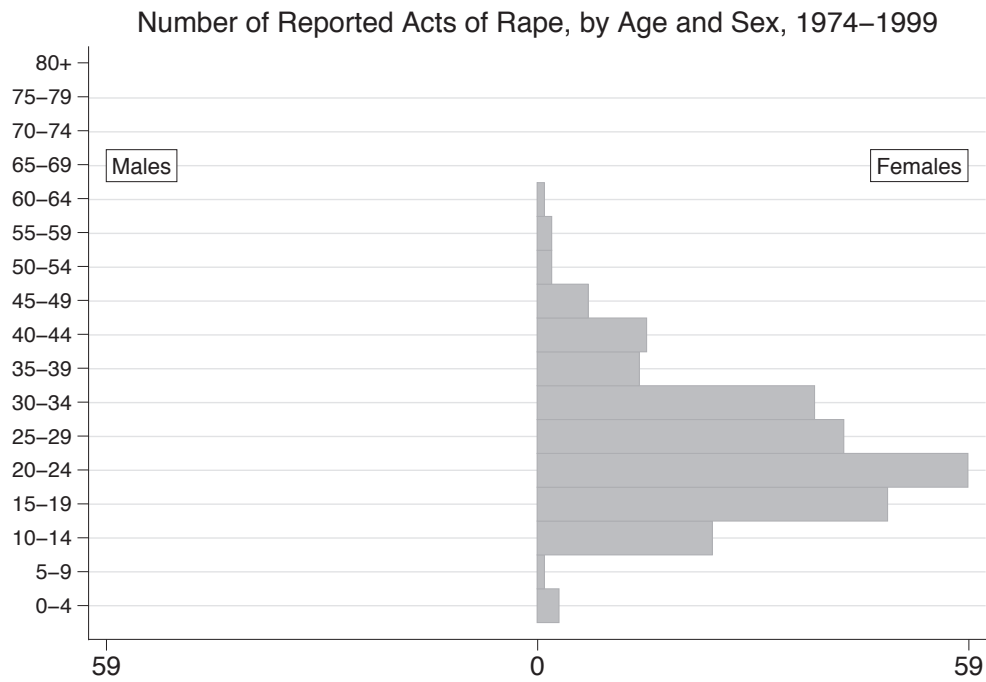

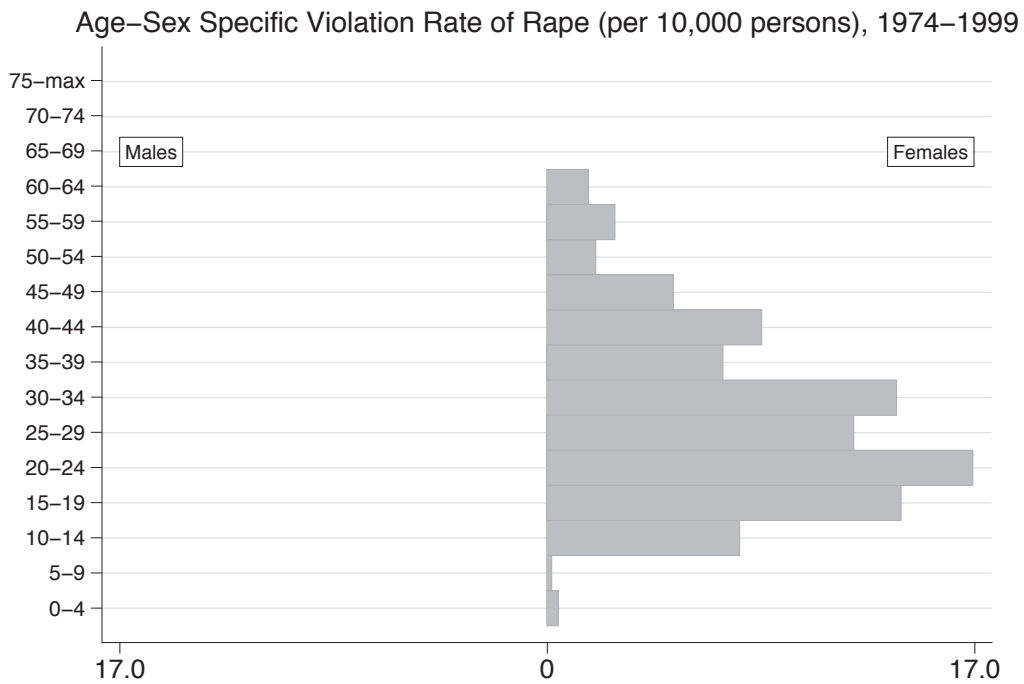

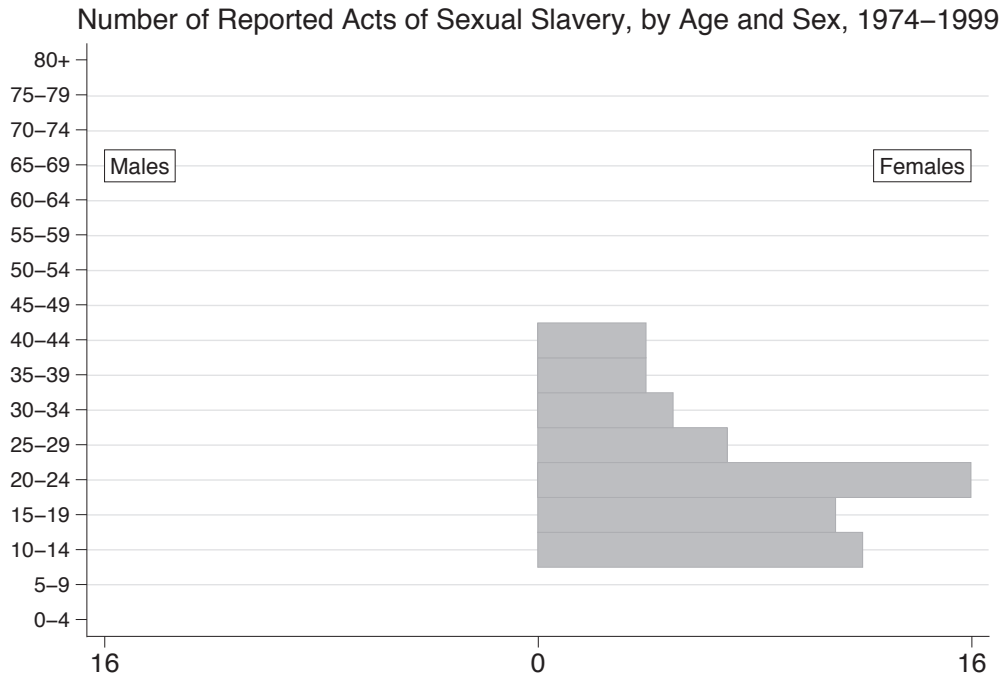

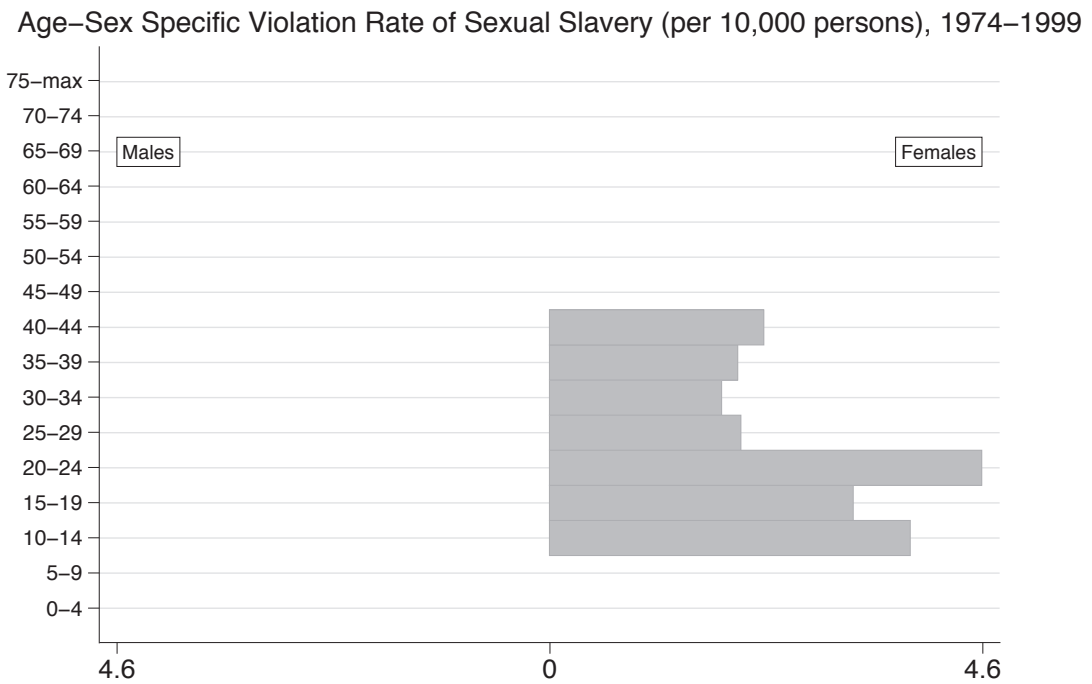

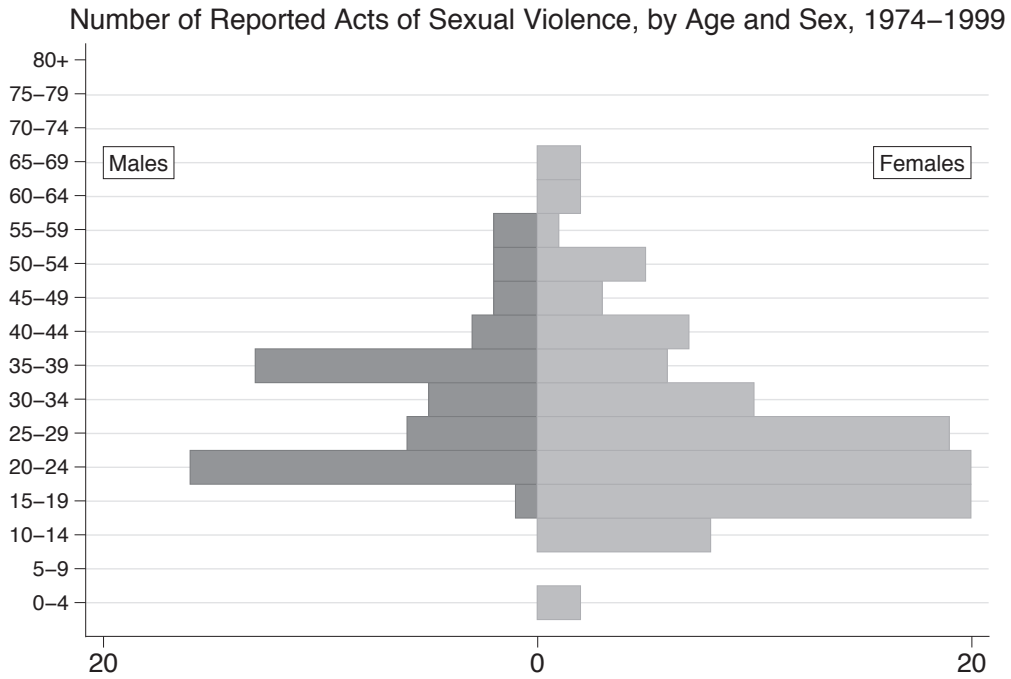

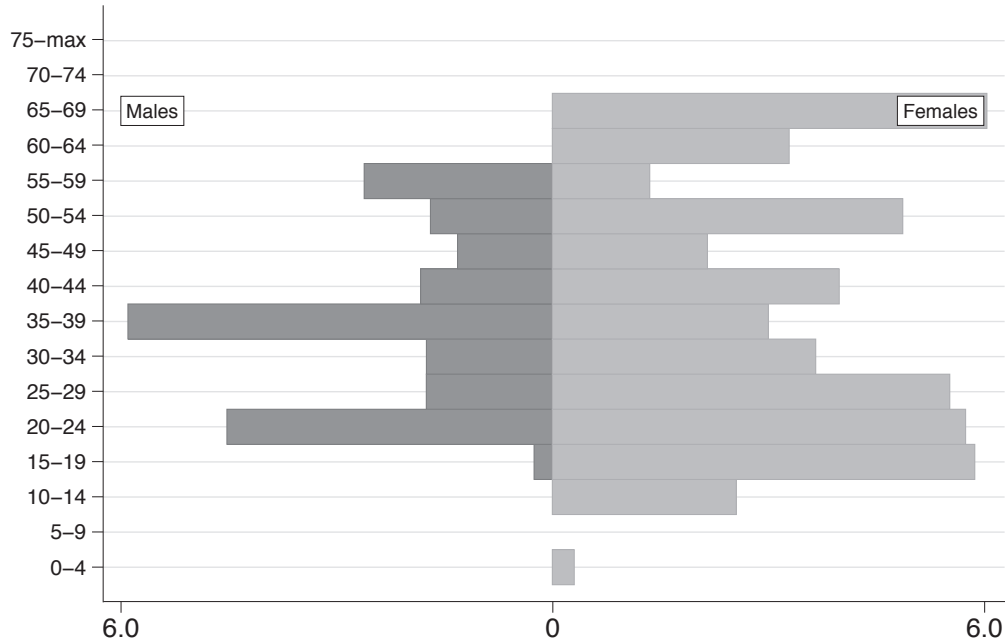

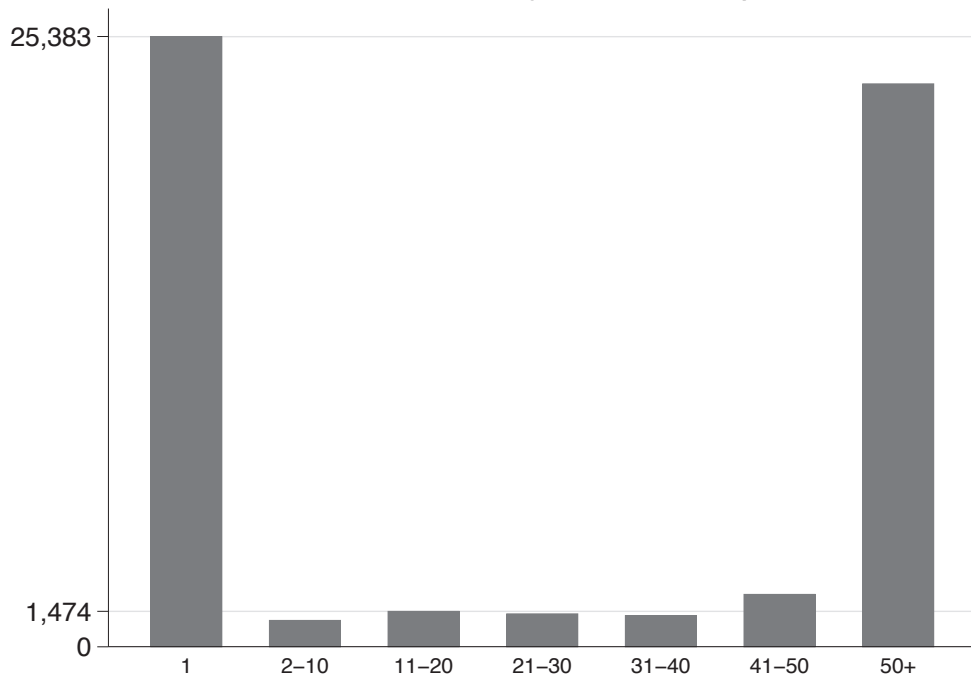

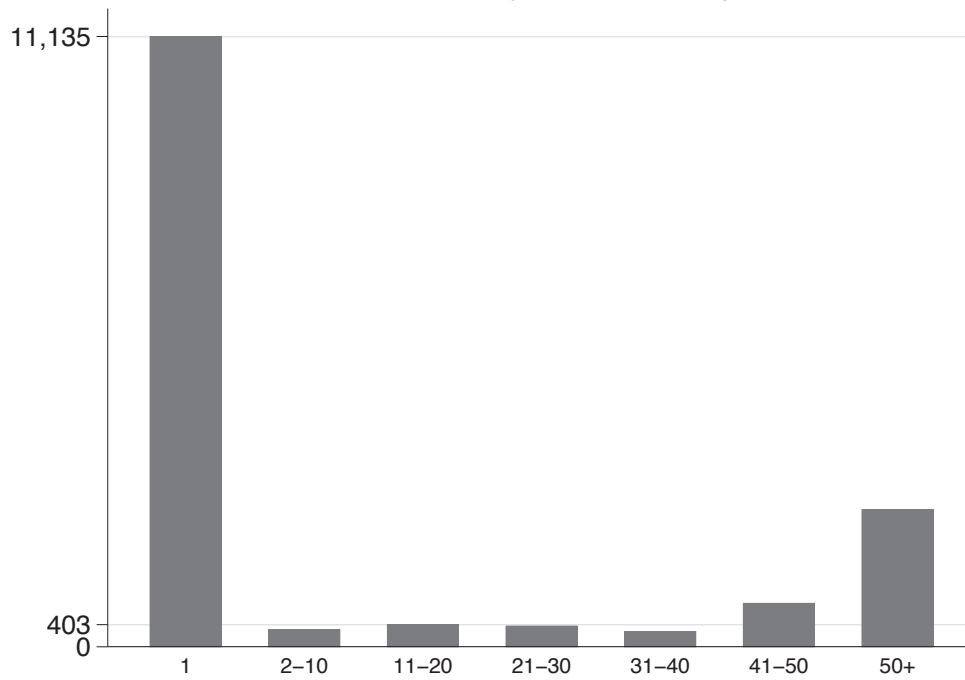

Count of Victims of Acts of Torture by Victim Group Size, 1974–1999

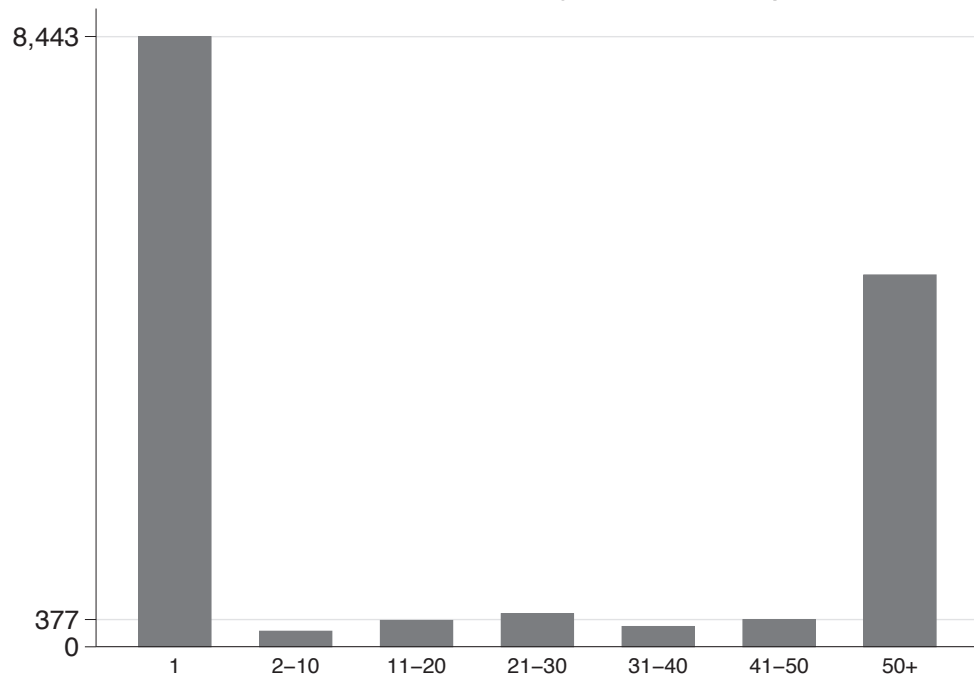

Count of Victims of Acts of Ill-Treatment by Victim Group Size, 1974–1999

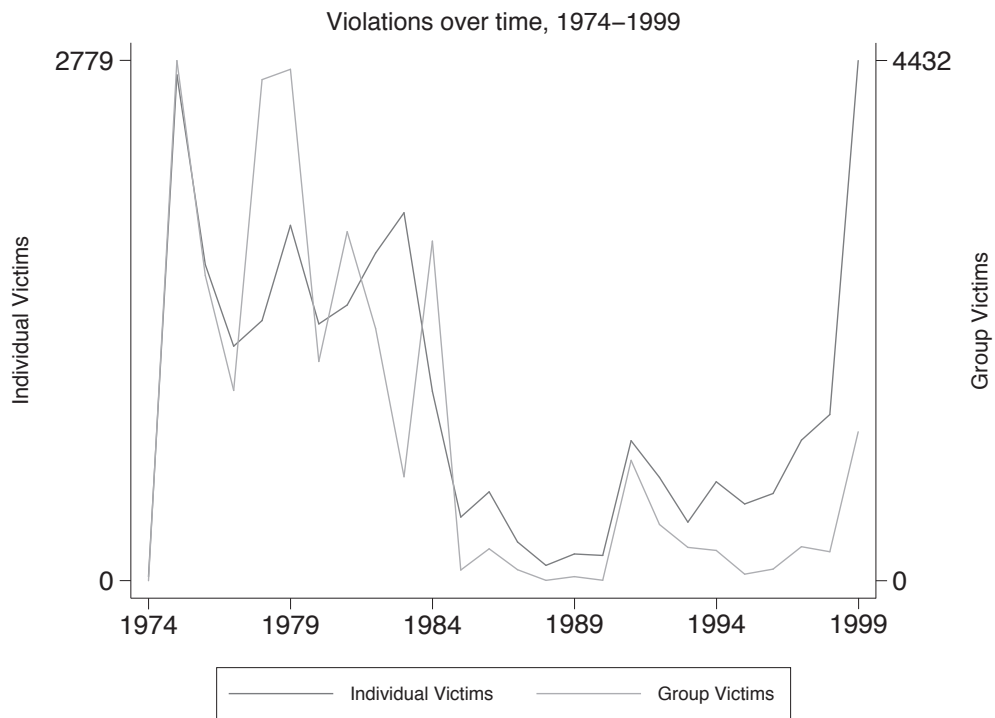

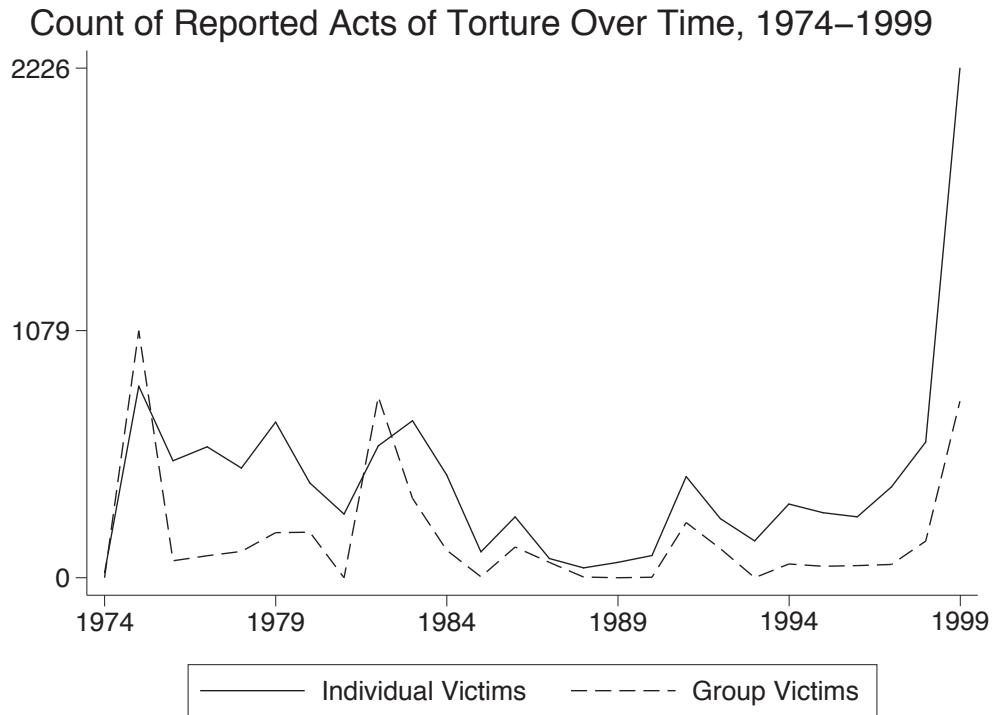

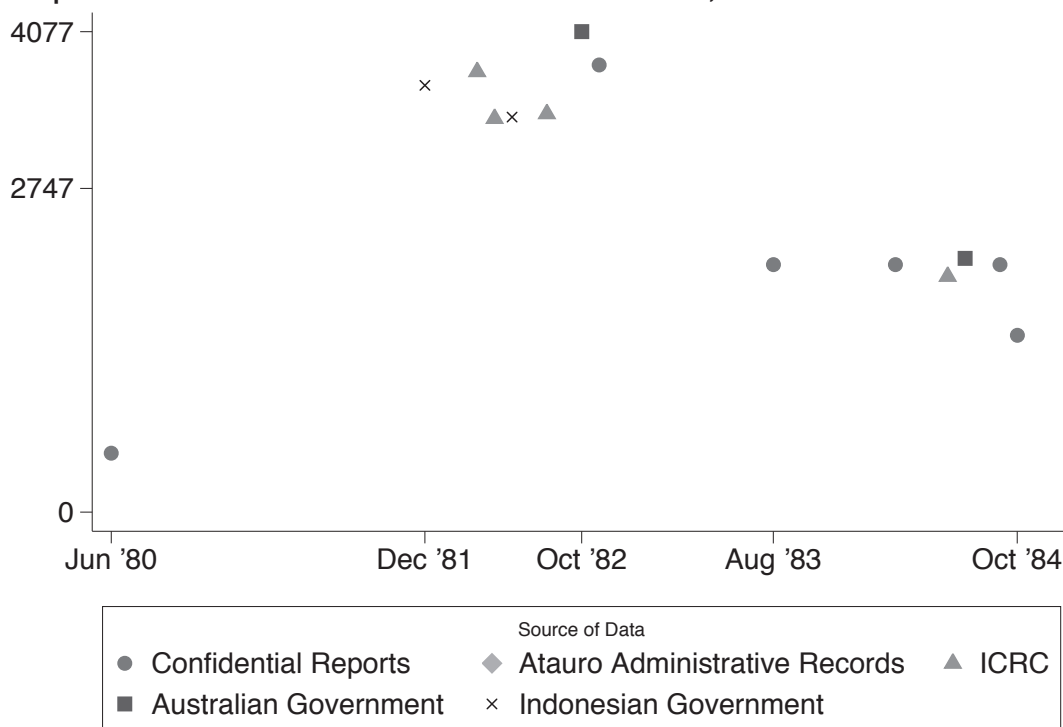

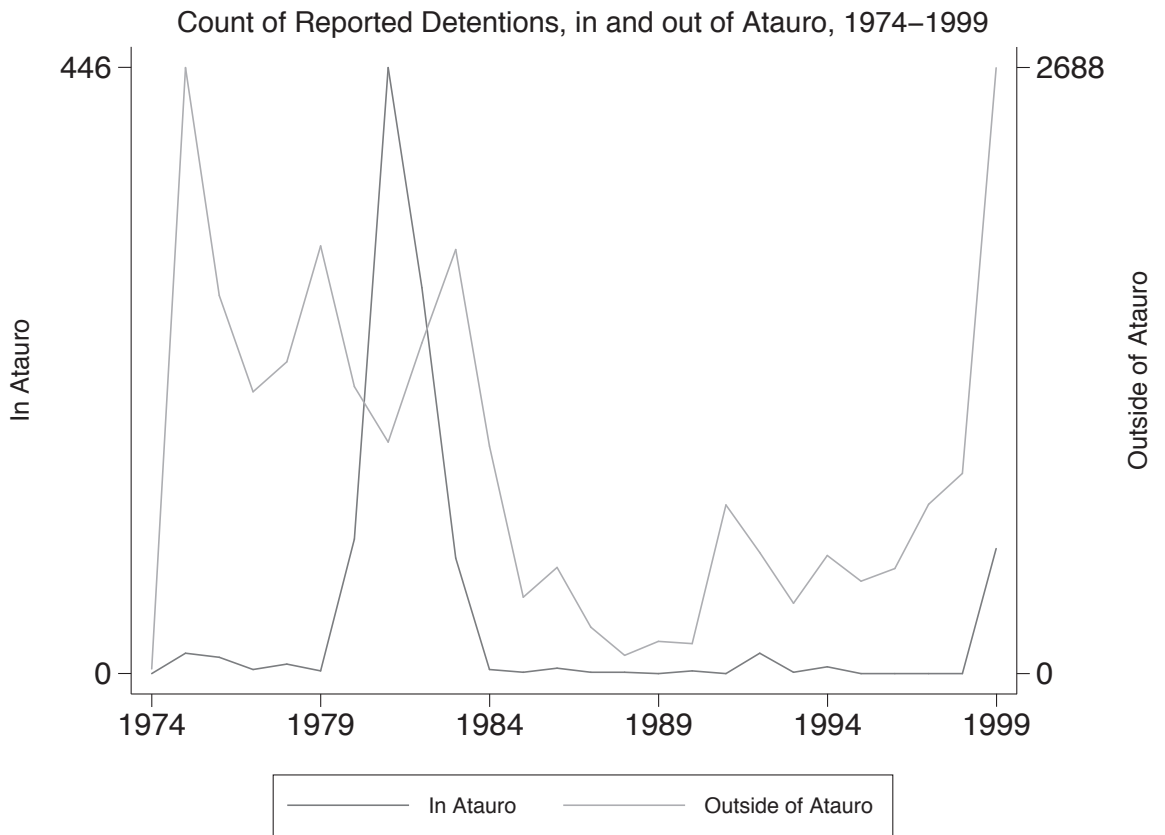

Reported Number of Detainees on Atauro, June 1980–October 1984



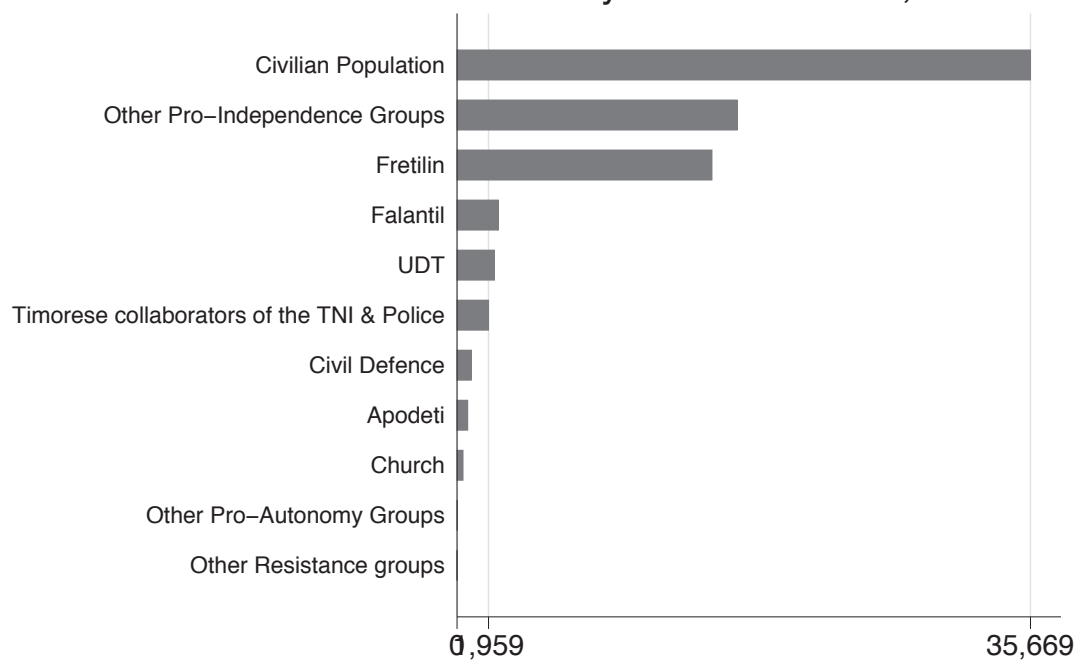

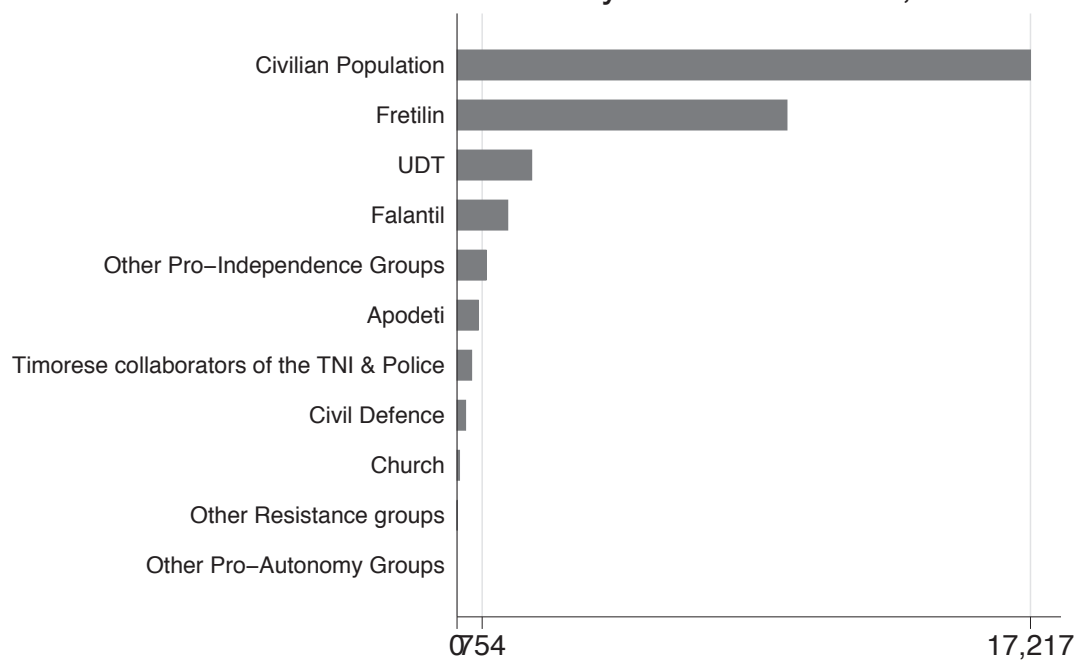
### Reported Acts of Non Fatal Violations by Victim Affiliation, 1974–1999

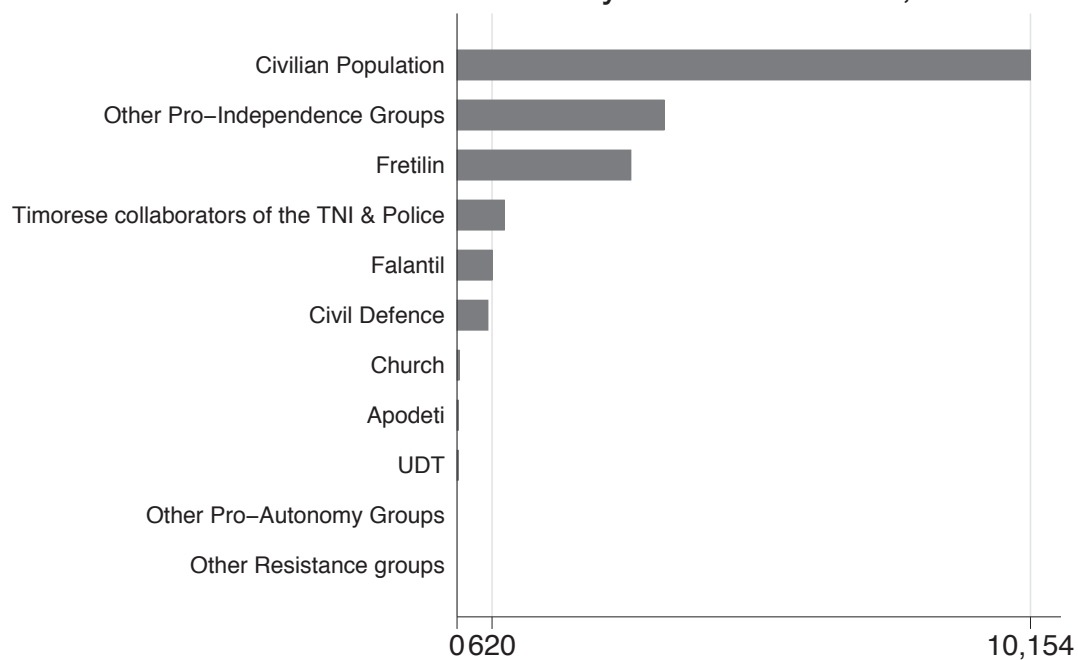
### Reported Acts of Non Fatal Violations by Victim Affiliation, 1974–1979

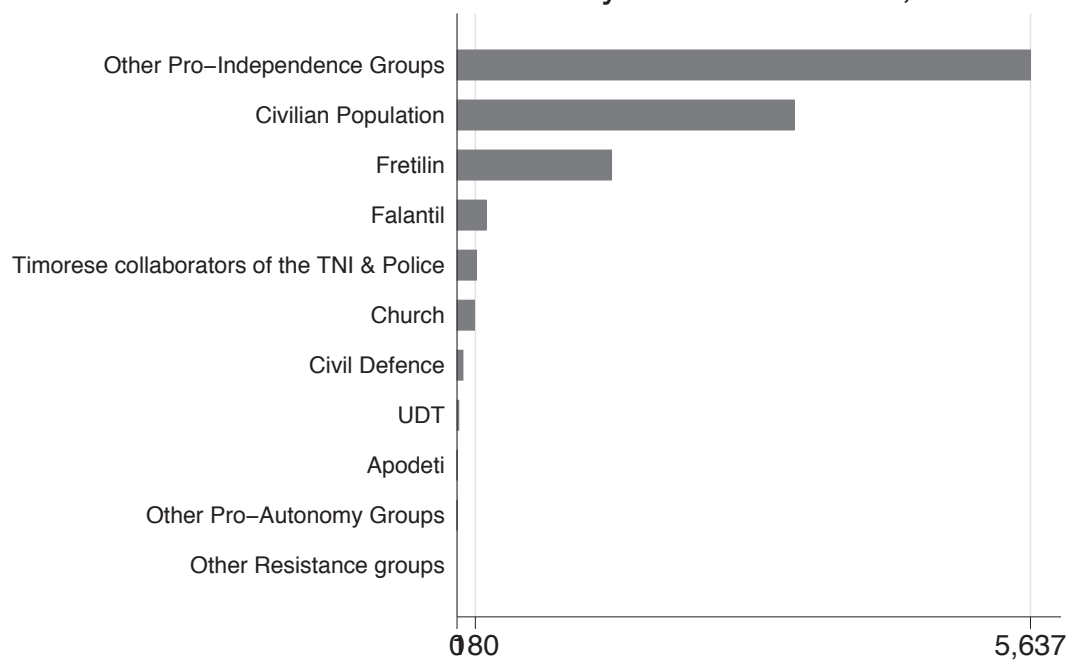
### Reported Acts of Non Fatal Violations by Victim Affiliation, 1980–1989

### Reported Acts of Non Fatal Violations by Victim Affiliation, 1990–1998

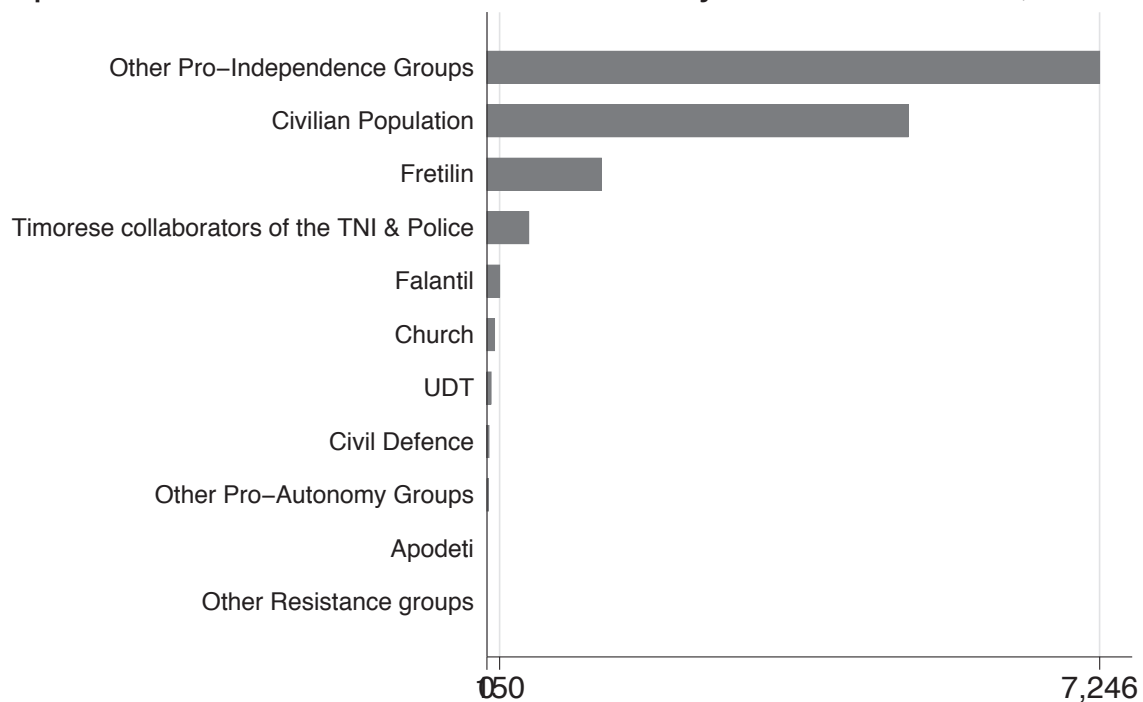

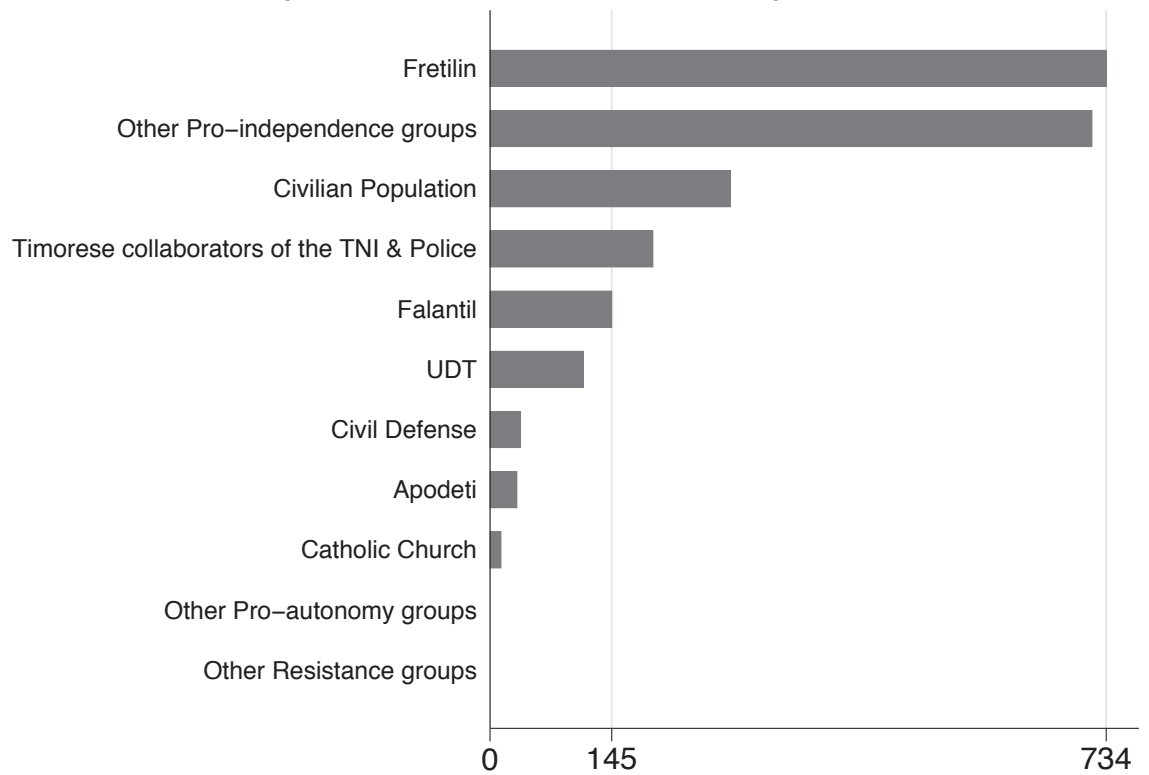


### Reported Acts of Non Fatal Violations by Victim Affiliation, 1999



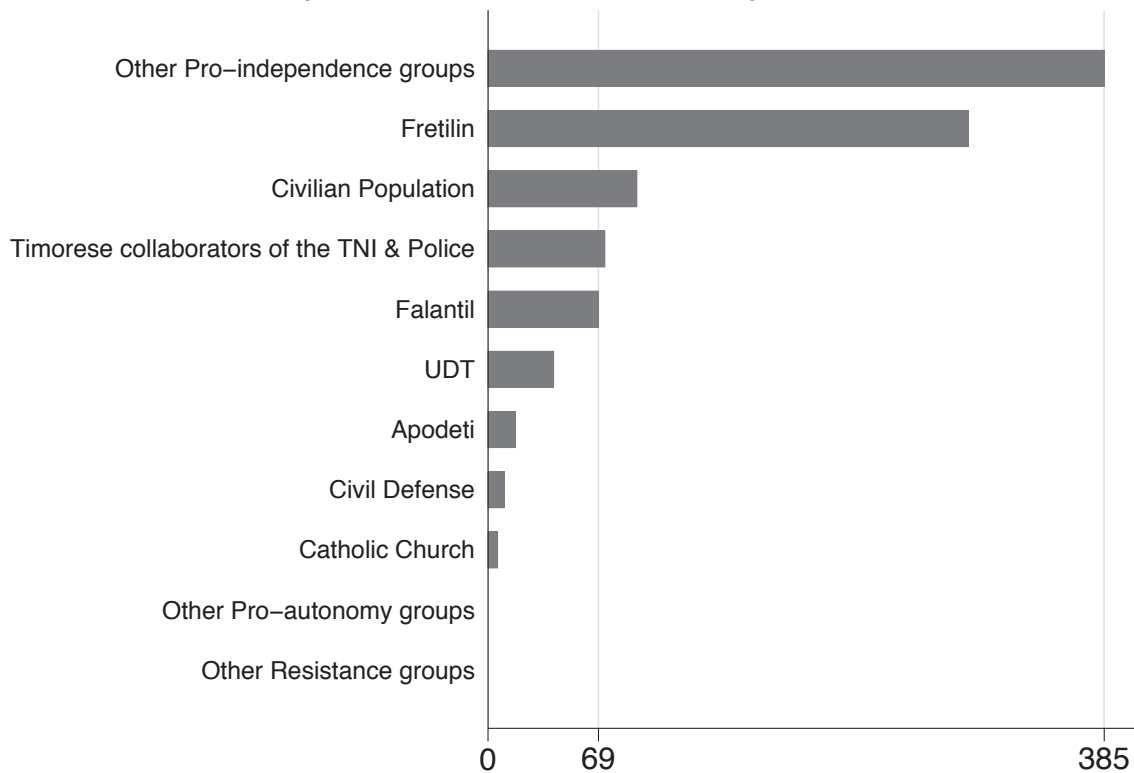

### Number of Reported Acts of Detention, by Victim Affiliation



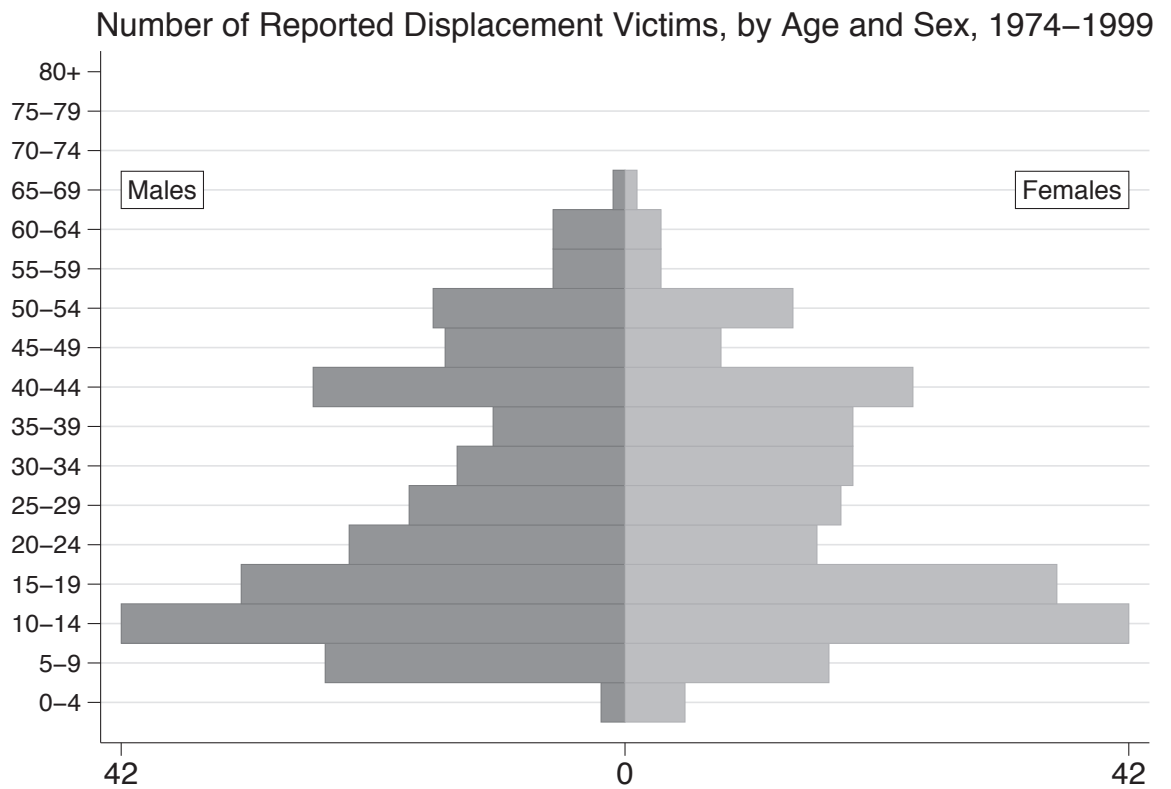

### Number of Reported Acts of Torture, by Victim Affiliation



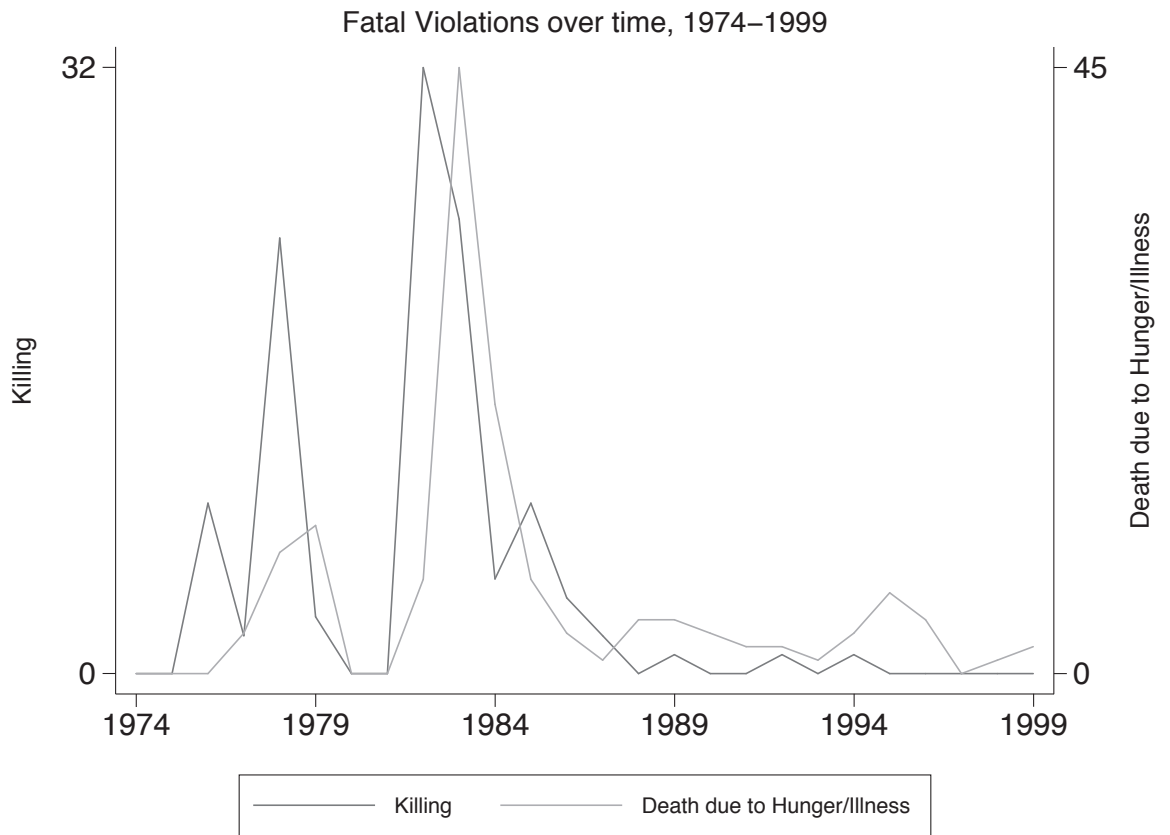
