
Non Fatal Violations over time, 1974–1999, committed by Police


Count of Reported Acts of Detention Committed by UDT by District, 1974–1979













Reported Number of Detainees on Atauro, June 1980-October 1984





Reported Acts of Detention Attributed to TNI, Police and Timorese Auxiliaries, 1999




