### A signed MoU between Centro Chega! and Political Conflict Victims Association 1974-1999

Dili, 21 February 2025 – The Centro Nacional Chega! I.P. has signed a three-year Memorandum of Understanding (MoU) alongside the Political Conflict Victims Association 1974-1999 at the Support Office of Centro Chega! Organ, Antigo Comarca-Balide. This MoU will be implemented from March to December 2025 and aims to strengthen the partnership and enhance the institutions' capacity to support various activities, including historical days, commemoration, organizing national and municipal advocacy networks for survivors, and recording and preserving the memories of the most vulnerable victims. These efforts are part of the broader commitment to strengthen the national economy as outlined in the Chega! and Per Memoriam Ad Spem reports recommendations for the responsibilities of solidarity toward victims and even other services for them.

The foundational principles for establishing cooperation involve dignifying and promoting values, fostering the spirit of solidarity, being considered inclusive, and working for the victim to support developing network cooperation. The services toward the victims of the war are in recognizing individuals, families, communities, and patriots dedicated to the liberation of Timor-Leste to provide adequate support for their well-being, enabling them to participate in national development.

Additionally, this MoU addresses the Annual Plan of Centro Chega! for 2025, specifically the program "Combatente da Libertação Nacional," which includes the subprogram "Serviço de Advocacia e Atividade de Fortalecimento de Associação de Vítimas e Instituição da Resistência" under the IX Constitutional Government, outlines the government's commitment to supporting the Centro Chega! I.P.'s initiative aimed to assist the most vulnerable former political prisoners and promote peace and reconciliation at the community, national, and international levels. This initiative serves as a formal implementation of the recommendations from both Chega! and PMAS.

In 2018, the Centro Nacional Chega! I.P. undertook various initiatives based on the Chega! and PMAS recommendations, all aimed at supporting survivors. These activities included: Developing a Training Program for the Survivors Group, Reunification of stolen children with their families, Strengthening the Survivors' Organization, Providing counseling and assistance to survivors, Commemorating historical days, Offering Punctual support to Survivors through the Ministry of Solidarity for Social Inclusion (MSSI), Delivering physical and mental health assistance in collaboration with the Ministry of Health, Establishing a database of survivors, Supporting humanitarian assistance, Collaborating with the Political Conflict Victims Associations (1974-1999) to build a Memory House to Hope to the Survivors, Establishment of a National Reparation Policy, and Task Force to prepare for the enactment of the Reparation Law. These efforts demonstrate a strong commitment to solidarity, healing, and reparation for those affected by past injustices.
